This list may not include prices for certain items that you select, such as cemetery charges or crematory services, floral arrangements, and newspaper notices. The estimated or final prices for those items will be shown on the itemized statement describing the funeral services and merchandise you selected. We charge you for our services in buying certain items.

#### **FTC Disclosure:**

The Federal Trade Commission (FTC) and the New York State Department of Health both require that certain disclosures be made by funeral providers on the General Price List. Although these disclosures are similar, they are not exactly the same. This General Price List contains both sets of the required disclosures. # Alternative Services

The following charges for direct burial and direct cremation **do not include** additional items or services, merchandise, facility use, and livery that the customer may wish to select.

## DIRECT CREMATION...

(Prices range from \$18500.- \$2100.)

...Which includes the local transfer of remains to the funeral home, staff services, securing of necessary authorization, basic local transportation to the crematory and return of the cremains to the funeral home.

***\*\* (FTC) "If you want to arrange a direct cremation, you may use an unfinished wooden box or an alternative container. Alternative containers can be made of heavy cardboard, pressed wood or composition materials (with or without an outside covering), or may be pouches of canvas or other materials." \*\****

Direct Cremations range:

***From..... \$1,850.***

Which includes the services as described above but with the alternative container supplied by the customer. Please see the **bolded FTC** guidelines referring to what materials are acceptable alternative containers you may use.

***To..... \$2,100.***

Which includes the services as described above but with the alternative container supplied by the Funeral Home. The alternative container we supply is a corrugated cardboard-unfinished wood box.

**NOTE:** The above charges **DO NOT** include the cremation fee.

# Alternative Services continued...

## DIRECT BURIALS...

(Prices range from \$2,495.- \$2,995.)

Which includes the local transfer of remains to the funeral home, staff services, securing of necessary authorizations, basic local transportation to the cemetery.

Direct Burial Packages,

### **\$2,995.**

Which includes the services as described above but with minimum casket supplied by the Funeral Home. The minimum casket we supply is a cloth-covered fiberboard casket.

### **\$2,995.**

Which includes the services as described above but with an unfinished wood box supplied by the Funeral Home.

### **\$2,495.**

Which includes the services as described above but with the casket supplied by the customer.

### **\$2,495.& Up**

Same as described above but the casket is supplied through our Funeral Home and is selected by the client from our casket selections.

**NOTE:** Direct burial prices **DO NOT** include cemetery charges or vault company charges. Nor does it include an outer burial receptacle (vault) which may be required by the cemetery if interment (earth burial) is the choice of final disposition.

# Professional Services:

## REMOVAL & TRANSFER OF REMAINS

Transfer of the remains to Bond Funeral Home within or up to a local 20 mile radius including personal, equipment and vehicle.

## PREPARATION OF REMAINS:

### NOTE: In New York State, embalming is not required by law...

If you do not want embalming, you have the right to choose an arrangement which does not require you to pay for embalming such as a direct cremation or direct burial. However, if you select certain funeral arrangements, such as viewing or an open casket funeral, embalming may be necessary and required by the funeral firm.

### Body Identification:

No matter what the funeral arrangements are, the customer has the right to see the body briefly. If this process is over 20 minutes, the funeral director will consider it a viewing or visitation and a fee of **\$175.00** will be required.

### OTHER PREPARATION (Excluding Embalming)

*Preparation of the remains, unless selected, is not required for direct cremation or for direct burial.*

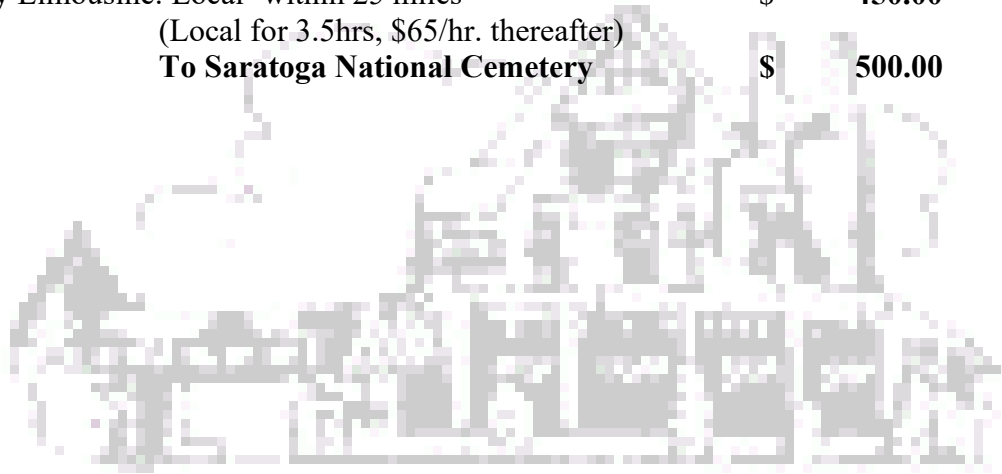

## Limited Services:

### FORWARDING REMAINS TO ANOTHER FUNERAL HOME: \$ 2,875.00

This charge includes the transfer of the remains to the funeral home, staff services, securing necessary authorizations, local transportation to point of shipment, and a minimum shipping container. The charge does not include shipping charges or additional items of services, merchandise, facility use, and livery that the customer may wish to select

**NOTE:** Transportation beyond local point of shipment will be billed either as livery or common carrier charges depending upon the forwarding location. Local point of shipment is up to 20 miles.

### RECEIVING REMAINS FROM ANOTHER FUNERAL HOME: \$ 2,275.00

This charge includes basic transportation of the remains to the funeral home and/or place of local disposition, staff services, and securing necessary authorizations. The charge does not include additional items of services, merchandise, facility use, and livery that the customer may wish to select.

**NOTE:** Transportation beyond a local place of disposition will be billed as livery charges. Local place of disposition is up to or within 20 miles.

**CASH ADVANCES:** Services and merchandise provided as cash advance items will be billed at the same amount paid by the funeral firm. Third-party vendors that provide these items expect payment at the time these services are rendered. These items should be paid for prior to the funeral service at the time of the arrangements are made with the funeral director.
