Complete Form W-4 so that your employer can withhold the correct federal income tax from your pay.

Give Form W-4 to your employer.

Your withholding is subject to review by the IRS.

Step 2:**Multiple Jobs

Complete this step if you (1) hold more than one job at a time, or (2) are married filing jointly and your spouse also works. The correct amount of withholding depends on income earned from all of these jobs.

Do **only one** of the following.

- (a) Use the estimator at www.irs.gov/W4App for the most accurate withholding for this step (and Steps 3–4). If you or your spouse have self-employment income, use this option; **or**
- (b) Use the Multiple Jobs Worksheet on page 3 and enter the result in Step 4(c) below; **or**
- (c) If there are only two jobs total, you may check this box. Do the same on Form W-4 for the other job. This option is generally more accurate than Step 2(b) if pay at the lower paying job is more than half of the pay at the higher paying job. Otherwise, Step 2(b) is more accurate ☐

(b) **Deductions.** Use the Deductions Worksheet on page 4 to determine the amount of deductions you may claim, which will reduce your withholding. (If you skip this line, your withholding will be based on the standard deduction.) Enter the result here **4(b)** \$

(c) **Extra withholding.** Enter any additional tax you want withheld each pay period **4(c)** \$

FAILURE TO ACCEPT NEW ASSIGNMENT MAY AFFECT UNEMPLOYMENT BENEFITS

PLEASE NOTE: Failure to follow the following procedure will affect your ability to receive unemployment benefits if your employment with Minnesota Staffing ends:

I understand that I must work with Minnesota Staffing's scheduling coordinator for temporary job assignments with customers of Minnesota Staffing.

I also understand that when each temporary job assignment is completed, within five calendar days I must affirmatively request an additional job assignment. If, within five calendar days, I (1) fail without good cause to affirmatively request an additional job assignment, or (2) refuse without good cause an additional suitable job assignment offered to me, I shall be considered to have voluntarily quit my employment with Minnesota Staffing, which means I will be disqualified from unemployment benefits.

"Good cause" means a reason that is significant and would compel an average, reasonable worker, who would otherwise want an additional temporary job assignment with Minnesota Staffing, (1) to fail to contact the company, or (2) to refuse an offered assignment.
