FIRST ROUND TO LAST 16 (part 2 of 2)

RULES

All players must be present at the time stated, otherwise they will be disqualified from the competition.

Each game comprises best of three legs, each of 501 up.

Start and finish on a double (bull counts double 25).

In first and third legs, the toss of a coin decides who goes for bull first, nearest bull throws for double first.

Alternate player throws for double first in the second leg.

Winners in matches 7 and 14 go through to the next round (last 16) to be played on Wednesday 20th May 2026

Note

If, when throwing for the bull, the dart of the person throwing bounces out, then another dart may be thrown until one remains in the board.

If the person throwing knocks their opponent's dart out of the board, then that person who has just thrown will win providing their dart remains in the board.

If both darts are knocked out, then both players must throw again in the same order.
