
COVID-19 Response

Chamber on the Go

Chamber On-the-Go connects small business owners in neighborhoods across the Bronx with free services, including: business courses, legal assistance, financing assistance, incentives awareness, navigating government, recruitment assistance, training, selling to government, Minority and Women-Owned Business Certification, Locally Based Enterprise Certification, and Emerging Business Enterprise Certification. The Bronx Chamber of Commerce conducts a free Rapid On-Site Assessment, identifying your business strength and needs. A Chamber on the Go specialist then connects you to the resources that will help your business succeed. Chamber on the Go focuses on supporting and enhancing the various activities of the Chamber. The goal of this outreach is to provide on-site assistance to business owners throughout The Bronx.

The Bronx Chamber of Commerce has Reached and Served over 1,500 businesses over the course of 3 years.

5 Chamber Alliance

Thanks to support from the TD Bank Charitable Foundation, there is funding to support the 5 Chamber Alliance and coordinate service delivery across the five boroughs. The goal of the 5 Chamber Alliance is to support businesses and individuals in low- to moderate income and immigrant communities. The Bronx Chamber of Commerce has worked with the 5 Chamber Alliance on putting together over 15 workshops to help support businesses and individuals.

MWBE (Minority and Women Owned Business Enterprises Certification)

The City of New York Minority and Women-Owned Business Enterprises (M/WBE) Program expands opportunities for minority and women entrepreneurs to access government contracts and grow their businesses. When eligible businesses are certified with the City they become more visible to prospective buyers, including City agencies and private contractors seeking to purchase goods and services.

The Bronx Chamber of Commerce has helped over 100 businesses in the course of the last 3 years, with both Certifying and Re-certifying their business.

Internship Connector

The Internship Connector Platform helps connect students at the Bronx Chamber's member colleges to internship opportunities with member businesses. The Chamber serves as a "hub" where internship postings, job



fairs & other events are made easily accessible for members via our website and email communications.




Minority or Women-Owned Business?




Business Borough

Committees

Membership/Business Development Committee

The primary goal of the Membership & Business Development Committee (MBD) is the formation of programs that create opportunities for growth and provide support for our members. MBD Committee members consult with the President and the Board in the areas of networking, member exposure to consumers, M/WBE Certifications, job fairs, workshops and seminars, directory resources, advocacy and the coordination of business principles within the efforts of other Chamber committees.

Finance Committee

Finance Committee is responsible for establishing the annual budget for the Board to ensure administrative continuity of the Programs and Services sponsored by the association.

Events Committee

The Events Committee is responsible for planning the formal Annual Gala, Golf Outing, Holiday Party, Hispanic Heritage Luncheon, African Heritage Luncheon, Irish Heritage Luncheon, and Italian Heritage Luncheon. Awards are presented to distinguished individuals at each event.

Legislative Committee

The Legislative Committee works directly with the Bronx Chamber of Commerce to advocate for improved economic conditions within the borough. This group also works to enhance the interaction between Bronx Chamber Members and public officials. Advocacy has emerged as one of the most significant areas that the Chamber can provide direct services to the full spectrum of businesses in the Bronx. 
