

# **Confirmation of Aboriginality**Procedure and Application Form

#### **Confirmation of Aboriginality Procedure**

Njernda Aboriginal Corporation (NAC) and its Board of Directors (Board) take the responsibility of confirmation of Aboriginality very seriously.

The Board will only consider applications where the applicant and their family heritage are proven and/or known to the Community, and where all the below eligibility requirements are met.

Only fully completed applications for Confirmation of Aboriginality will be presented to the Board for consideration at the next available Board meeting.

This position has been taken as these requests are generally for the purpose of seeking eligibility to services and opportunities that are exclusively for the benefit of Aboriginal and/or Torres Strait Islander people.

#### 1. Eligibility:

To meet this criterion, you must be able to satisfy all three parts of the following definition:

- a) Descent the individual can prove that a parent is of Aboriginal and/or Torres Strait Islander descent, demonstrated through providing a family tree (Appendix 1).
- b) Self-identification the individual identifies as an Aboriginal and/or Torres Strait Islander.
- c) Community recognition the individual is accepted as such by the Aboriginal and/ or Torres Strait Islander community in which they live (two separate written and signed references will be required).

#### 2. Locational Eligibility:

This criterion relates to the coverage of NAC being for the Aboriginal and Torres Strait Islander Community as Echuca-Moama to meet this criterion, you must be:

- a) from Echuca-Moama and you still currently living in the local area; or
- b) from Echuca-Moama or have lived the majority of your life in Echuca-Moama, but you are currently living elsewhere, or
- c) born and/or raised in Echuca-Moama; regardless of where your family is from; or
- d) from a community outside of Echuca-Moama, but you have lived the majority of your life in Echuc-Moama; or at least the past 5 years.

#### Notes:

- In cases of Stolen Generation or disconnection from family, the Board will consider applications where you can provide clear supporting documentary evidence (e.g., from Link-up or other such family history or reunification services) that your family heritage is of Aboriginal and/or Torres Strait Islander descent.
- If you identify as a Yorta Yorta Nation Traditional Owner, you will be required to provide supporting documentation.
- If your family heritage is from outside of the Yorta Yorta Traditional lands and you do not meet the above criteria, your application will not be accepted. You should instead seek your confirmation from a relevant local Aboriginal Community Controlled Organisation in the area where your family is from.
- If you are under 18, if one or both, of your natural parents have had their Aboriginality confirmed by Njernda Aboriginal Corporation, you are automatically eligible for confirmation upon supply of your Birth Certificate identifying your parent(s) by name. If you are able to, provide a completed Family Lineage Chart and/or a copy of your parents' Confirmation of Aboriginality, this will help us process your application.

#### 2. Completing the application form

- This application must be correctly and fully completed.
- If you do not provide sufficient documentation, then your application will not be considered by the Board and will be returned to you for completion.
- Confirmation of Aboriginality remains entirely at the discretion of the Board. Despite an application being
  complete, if the Board cannot confirm any knowledge of the applicant or their family heritage, they will not
  approve the application.
- Decisions will not be revisited unless the Board is provided with significant new evidence that may affect the decision made.
