### **Background**

Involvement in sport, recreation and artistic activities is an important contributor to health and wellbeing and plays a strong role in social development. In some cases, community members or teams may need assistance to take part.

Where funding is available, *Njernda Aboriginal Corporation* may provide sponsorship to community members (individuals and teams) to encourage involvement in sport, recreation and artistic activities.

## **Policy Statement**

Depending on the availability of funding, *Njernda Aboriginal Corporation* will look to support eligible community members to participate in sport, recreation or art through sponsorship. Only children and youth aged up to 18 years are eligible for funding. Payment will be capped at the below amounts for everyone as follows:

- \$500 per child for single parent family per year;
- \$250 per child for coupled parents receiving an income per year;
- Kinship and Out of Home carers will receive \$500 per child per year for any activity.

Funding is strictly only available for memberships, registrations, footwear and uniforms. Only one pair of sporting footwear can be purchased which does not exceed the value of \$100 (if it is more parents are required to cover the extra cost).

Acknowledgement of the sponsorship through media, on information packages or signage is requested, where practical.

### **Procedure**

Njernda's fee application form (refer - **Appendix A**) must be completed and signed by parents/guardians and provided to Njernda's Community Engagement Worker.

Applicants need to allow up to four weeks for their application to be assessed. Applicants should apply as early as possible to increase their chances of being allocated funding. Note - sponsorship is based on the availability of funding and does not guarantee reimbursement.

Payments will only be granted on receipt of an invoice or a quote for membership/registration and or footwear or uniforms is provided to Njernda from the appropriate organisation.
