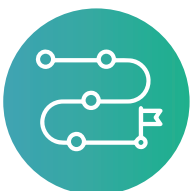

Glenfield Grange Retirement Village

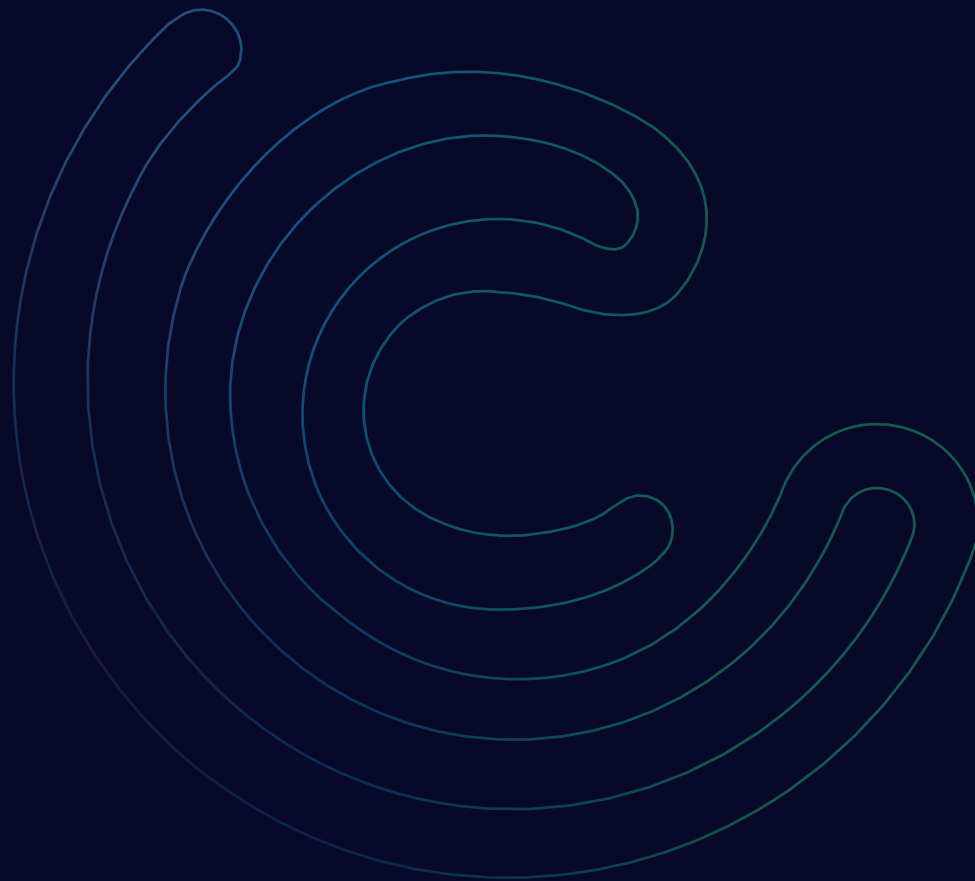
