

There is no better feeling than having important tasks completed ahead of time, and the sooner you start, the more relaxed you'll feel. Your Advance Funeral Plan is an essential part of your affairs, but there are many other aspects to consider as well. This guide will help:

1. Write Down Your Contact List

Make a list of all the people who should be notified in the event of your death. This might include friends, neighbors, employers, your attorney, your religious advisor, and so on. Include phone numbers, addresses and email addresses. This will be invaluable to your family.

2. Update Your Will

If you have not yet made a will, now is the time. Your attorney can customize your will to fit your unique situation. Or, you can make a very basic will yourself. Much information is available free to the public, so visit your local library, or search the internet. Equally important, you should review your will often and keep it up to date.

3. Select Your Executor

Your executor is the person you appoint to carry out the terms of your will. You can appoint co-executors, or even an institution. Obviously, your executor should be trustworthy, honest and experienced in financial matters. Think carefully about this decision. It's wise to get the advice of an attorney

4. Consider a Living Will

A living will is a written statement of your desires about medical treatment if you should no longer be able to express your thoughts. For instance, in what circumstances would you want life support? Whatever your desires, a living will relieves your family of what might be painful decisions. Ask your doctor for advice about a living will.

5. Consider a Power Of Attorney

A Power of Attorney (POA) is a written document in which you appoint another person to act on your behalf in certain matters, for instance, legal, financial, or health care. POAs can be limited in various ways, and they can sometimes prove extremely useful. You'll need the advice of an attorney to decide if a POA is right for you.

6. Make a List of Your Property, Assets & Debts

This list will be an immense help to your family and the executor of your will. Of course, you will need to review this list each year and keep it up to date. Note: be sure to keep this list in a secure place, such as a safety deposit box.

- ✓ Real Estate—List all your real estate, including addresses and locations of deeds. Include recent appraisals and property tax records.
- ✓ **Personal Property**—List valuable personal property such as artwork, antiques, jewelry and family heirlooms, along with their locations. Include any recent appraisals.
- ✓ **Financial Assets**—List all bank and brokerage accounts and other financial assets, along with account numbers and contact information.
- ✓ **Debts**—List all debts you owe, including mortgages or other bank loans, credit card accounts, and current tax debts. Include account numbers and contact information.

7. Organize Your Tax Records

Maintain a file of your tax records going back at least three years. Be sure all information needed for the current tax year is included as well. If applicable, include the name and contact information of the person who prepares your tax filings.

8. Review You Insurance Policies

List the location of all your insurance policies. For instance, if you store them in a safety deposit box, list the bank name and box number. Also list any insurance agents you may have. Each year, review your insurance policies to make sure your coverage is up to date.
