Council Member Fahy has been contacted by Jim Bross with the Recycle Center regarding applying for a grant to help with improvements to the center. After a brief discussion the council would rather see if we can seek donations to help with the repairs. Council Member Fahy also reported on projects that the City has done and that they look nice.

Street Commissioner Dornberger reported on a meeting that was held with Engineer Mark Bross. They had a discussion regarding next projects that need to be looked at .

Council Member Zach Jones reported on the Community Pool . Park Director Doug Meyers is applying for a DNR Grant that will be awarded in 2027 to help with the repairs to the pool . The plan at this time is to repair the pool floor, remove the kiddie pool, and possibly put in a small splash pad . The council has requested a head count for the pool and to look at where they stand financially at the end of the season. Deputy City Clerk Olson will get that pulled together and submitted to the council members.

Mayor Adrian reported that the City of Palmyra has been awarded the MODOT Tap Grant in the amount of \$478,000.00 for the downtown sidewalk project on the west side of the street.

The new billboard for the Warren Head Business Park has been installed.

Mayor Adrian gave an update on the mural that the high school is redoing. They are hoping to have this done this fall.
