Prior to drafting any contract for goods or services, the responsible party or the decedent's survivor who is handling the funeral arrangements is entitled to receive a copy of any preneed agreement in the possession of the funeral establishment that has been signed and paid for, in full or in part, by or on behalf of the decedent."

The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

Basic Services of the funeral director, staff, and overhead:..... \$947.00

This fee for our basic services will be added to the total cost of the funeral arrangements you select. This fee is already included in our charges for direct cremations, and forwarding or receiving of remains. This fee includes the following:

- Preparing the death certificate and permits
- Personnel available 24 hours a day, 365 days a year to respond to the initial call
- Arrangement Conference
- Coordinating service plans with the cemetery, crematory, and/or other parties involved in the final disposition of the decedent
- Clerical assistance in the completion of various forms, death certificate and permits associated with a funeral.
- Overhead included facility maintenance, equipment and inventory costs, insurance and administration expenses, and governmental compliance.
- Carbon offsets to ensure that all services are carbon neutral.

Minimum Services

Minimum services are a “direct cremation”. These are reduced-cost services without a ceremony.

Includes basic services of professional staff, transfer of the deceased into our care, sheltering of remains, cremation process, and cremation container. *Covers transportation from San Bernardino and Riverside. Additional costs for Orange, Los Angeles, and San Diego Counties to our licensed refrigerated facility in Anaheim, CA.*

- One (1) Disposition Burial / Cremation Permit (Health Department Fee)\$12.00
- California State Regulatory Fee (State Tax) \$11.50
- Coordinating with the local medical examiner/ coroner if required
- Administrative assistance for communications with the responsible parties
- Managerial support to supervise and document the process. *(Does not include any County Coroner fees should they apply or transportation back to the coroner if needed.)*
- A cremation container made of approved material, in which the body is placed for cremation
- The crematory fee
- Urn for the cremated remains
- Delivery of cremated remains (via USPS Priority)\$175.00

The Identification Viewing service will take place at our crematory in Anaheim, CA. (Does not include additional preparation costs if they are desired).

Forwarding of remains: Please note that our facility does not provide embalming services. As a result, we do not offer forwarding of remains, as this service typically requires embalming. This policy supports our focus on direct cremation services only.

Receiving of remains:.....\$1,297.00

This service applies when we transport your loved one from a funeral home. It includes a basic services fee, the transfer of your loved one into our care and sheltering of remains. (Transportation includes services within a 25-mile radius. Anything over 25-miles will incur an additional \$3.00 per mile.)
