God is my provider. I shall not worry.



MESSAGE FROM THE CHAIR

I ended my 2020 report with a quote from Martin Luther King, Jr. about storms not lasting forever. Our doors remained closed until October when we reopened with strict protocols in place to ensure the safety and well-being of those who wished to worship in the sanctuary. Those who share our space were not able to resume meeting at Westminster. All our community events were cancelled. There are some of our congregation whom we haven't seen in person since March 2020. We miss talking to them at the rear of the church and over coffee and goodies.

The Council was very pleased when Rev. Del Stewart agreed to extend his contract until June 2023. He continued to adjust to COVID restrictions and technology by conducting Zoom services when we were closed to in-person worship and once our doors opened again, he continued to do both in-person and Zoom services. We have improved microphones and Norm has other ideas percolating for enhancing our services both in the building and on air. Our Annual Meeting this year will be different with some people being in the pews and some at home on Zoom. We couldn't do all this without you, Norm. THANK YOU!

Thank you to the Property Committee who oversaw the painting and new floor in the Hearth Room and the renovation of the bathroom off the Hearth Room. Also, thanks to those who contributed financially towards these endeavours. Both look fantastic and hopefully we can gather in the Hearth Room again soon. The building continued to be cared for even when we were not in it. Office needs were looked after as needed. The Pastoral Care committee of Sandi McDonald, Val Derbowka and Bonnie Evoy have continued to do a fantastic job during this second year of shut down of keeping in touch with everyone. This personal contact remains vital in maintaining our connections with each other. While the majority of our fundraising efforts were interrupted, we still did Fundscrip and sold our turkey pies. Several of our community programmes, CanShare, Sparky's Toy Drive and the Mitten Tree for Hiatus House continued.

I want to thank the Westminster Council for all their work during the past year. Our meetings have all been on Zoom. I want to thank Amanda Ballermann who will be leaving the Council this year for all her efforts. She was instrumental in putting our first Website together so that we could reach others outside our walls. Fred Barkhouse, our Treasurer secured several grants which were available to churches during COVID and made sure that all our bills were paid.

Finally, to you, the members and adherents of Westminster, you are phenomenal. You continue to follow our COVID protocols. You continue to support the church financially during these difficult times and you let us know that you were still supportive of what we were doing. As a Council, we have always tried to be as transparent as possible. Please continue to ask questions and offer suggestions.

We continue to weather the storm and I hope that 2022 will see further lifting of restrictions as we work our way back to a new normal. It has been a journey and it's not over yet.

Several special projects took place while the Church building was closed. In late 2020, some of the ladies in the church began to investigate replacing the carpet in the Hearth Room. Fundraising was initiated in the Congregation; quotes were gathered, and a new vinyl floor was installed in early 2021.

It was decided after the flooring was installed that the paint needed to be refreshed. Thanks go to Kathleen Paterson who sponsored the redecoration carried out by her brother Jim Reid.

It was found that the Tecumseh Road steps had deteriorated and become unsafe, so major repairs were carried out by Garry and Doug and they are once again usable.

Thanks go to Bill Rankine and Fred Taylor who organized and sponsored the purchase of fixtures and remodeling of the bathroom located between the Sanctuary and the Hearth Room. Garry painted using some left over paint from the Hearth Room.

Thanks also to Norm Barnoff, who spent considerable time during the shutdown installing a new sound system in the sanctuary which is very noticeable during each Sunday Service.

TREASURER

Another year of pandemic restrictions was not what I expected to happen in 2021. This is the NOT so good news.

The GOOD news is the people of Westminster United Church continue to demonstrate their commitment to the life and work of Westminster, donating their time, talent and money. What an amazing community of faith we are all a part of. The annual report will show that the budgeted amount for weekly envelope collection just missed its target by a few hundred dollars. As the treasurer of Westminster, I cannot thank the members, adherents and guests of Westminster enough for your continued financial support. Without this support planning a budget and making decisions would be very difficult. Without this support our other funding efforts would be inadequate.

Westminster was able to obtain a couple of grants from the Ontario Government totaling Twenty Thousand Dollars (\$20,000.00). The Federal Government offered the Canadian Emergency Wage Subsidy which rebated the church about another Fifteen Thousand dollars (\$15,000.00) in paid out wages. There were some bequests totaling about Twelve Thousand dollars (\$12,000.00). With these monies and the continued and constant support of Westminster supporters Westminster was able to turn a deficit budget into a profitable budget.

Westminster's original 2021 budget (passed by council) showed a deficit of about Forty-Four Thousand dollars (\$44,000.00). The 2021 budget was revised in May of 2021 to reflect the Ontario government grants and Federal Government wage subsidy program. A credit from Enbridge Energy of about Twelve Thousand dollars (\$12,000.00) (for over estimating Westminster's gas bill for 2020) was also calculated in. The revision saw the deficit for 2021 reduced to less than One Thousand dollars (\$1,000.00). After the May revision the bequests were added to the income. I believe that, because the congregation has maintained its weekly giving goal of Sixty Thousand dollars (\$60,000.00) for 2021, whether using weekly envelopes, PAR or Canada Helps, these new-found and unexpected monies were able to make a significant difference to our bottom line. This has allowed Westminster to erase its deficit and show a profit of just over Twenty-Four Thousand dollars (24,000.00).

As we are all well aware in our personal lives the cost of everything is going up. Be it inflation, supply chain problems or the threat of conflict in other nations, taxes, everything costs more. Westminster's 2022 budget is no exception. As it

is being presented it is showing a deficit of about Fifty Thousand dollars. There will be no grants or wage subsidies from either government to take advantage of for 2022, as of this writing. If the good people of Westminster are able to go back to doing some of their usual fundraising in the fall this will certainly help improve the deficit as well.

For the first time in a long time (that I can remember) there will be a request from the treasurer for everyone to dig a little deeper. Maybe I will even use the "give up a Tim Horton's coffee or a Big Mac" so you can give a little more to the church. (Oh, how I despise this analogy) I make this ask of Westminster's financial supporters knowing full well that everyone is doing the best they can with their financial contributions already. But I will do my part and put the ask out there away.

I again thank all who are involved with Westminster for their time, their talent and their money. It makes being a treasurer so much easier and a member of Westminster worthwhile.

TRUSTEES

The overriding focus of the Trustees for 2021 continued to be the increasing cost of property insurance premiums.

Insurance

Many churches have seen their property insurance premiums increase significantly over the past two years. Westminster's Faith Protect property insurance premiums rose 33% in 2020. Westminster's 2021 budget of \$16,754 for insurance assumed an increase of another 10%. Initial quotations from our provider, All-Risks, for renewal based on the 2020 coverage was markedly higher than this.

To reduce this increase, Jim negotiated a reduction in coverage in three areas: building contents from \$639,000 to \$300,000; pipe organ coverage from \$773,000 to \$250,000; and flood endorsement from \$8,233,000 to \$7,370,000.

This reduced our premium effective September 29 through to the same date in 2022 to \$16,368 tax included.

The previous year's policy was extended 30 days to allow All-Risks time to seek out alternate insurers. None were deemed acceptable to All-Risks for various reasons including the age of the building and claims history. We incurred an added \$1,251 tax included in premiums for 2021 due to the extension. The total paid out in premiums (extension and 2021-22 renewal) on insurance in 2021 was \$17,620. The 2022 budget will be \$18,005—a 10% increase over last year's premium.

The United Church General Council is looking into the feasibility of self-insuring, which will take at least a year to work out. In the meantime, it is currently expecting a 15% increase in premiums for communities of faith using its group insurance plan, United Church Protect. Jim, on behalf of the Trustees, will investigate alternative brokers to All-Risks in 2022.

Pews

A member of the community, Carolina McLaughlin, enquired about buying one of the several excess pews removed from the sanctuary several years ago and put in storage. The Trustees approved the sale of a 7-foot pew to her for \$75. The sale did not proceed as no pews were available shorter than 7 feet. The Trustees also agreed to sell excess pews at \$10 per linear foot. No action has been taken on this.

The Trustees met formally in October via Zoom. They thank Del for his leadership and patience.

Special thanks to our frozen pie team of Julie Swettenham, Bev Marshall, Sandi McDonald, Jeanne Stocks, Jim Kennedy and Rose Barkhouse. All of you gave your time and talent to assemble, bag, label and freeze great pies for our members and friends of Westminster and those pies are greatly appreciated by everyone.

Requests have been made for more pies in 2022 and I am hopeful that we can also make beef pies as well!!

Finally, all of us loved the beautiful Christmas decorations in the foyer and the Sanctuary, which truly helped us get into the spirit of the season. Everyone pitched in and the job was completed quite quickly! It was a wonderful transformation, and we are very grateful for your creative talents.

In 2022, we are hopeful that Westminster will return to some of our regular fellowship activities, but until then let us continue to work toward good health and keep each other in our thoughts and prayers.
