

#### MINUTES OF THE ANNUAL MEETING OF THE CONGREGATION

## Minutes of the 2022 Annual Meeting of the Westminster United Church Community of Faith February 26, 2023

Following worship and a light lunch, we gathered in the Friendship Centre, and virtually on Zoom, for the Annual Meeting of the Westminster Community of Faith. There were 17 full members, 10 adherents, our minister, Rev Del Stewart and his wife, Wilma Lamb Stewart, present in person and 2 full members and 3 adherents present on Zoom. We were initially short one member to make quorum. Due to another commitment one member was delayed but was on the way. It was decided to begin the meeting and vote on the motions once that member arrived and quorum was reached. Said member did arrive part way into the meeting and we had a total of 20 full members present at the time we passed the motions made at this meeting.

Jeanne Stocks, Chair of the Council and the Congregation, called the meeting to order at 12:09 pm and welcomed everyone. She thanked the people who set-up our lunch and who will help with clean-up. She thanked Heather for the cookies and thanked Norm for setting-up the equipment needed for our Zoom participants.

Jeanne called on Rev Del to offer an opening prayer.

Jeanne spoke about our definition of an adherent. We recognize as adherents those people who are regular attendees of Westminster and regularly support the congregation and the work of Westminster but for one reason or another have not become "full members". You are an important part of this community of faith and we value your input.

<u>Moved, Seconded</u> that we grant adherents the right to vote on all motions brought before this meeting. (Marion Overholt, Jim Kennedy)

Rev Del Stewart led a "Time of Remembrance" reading the names of members and friends of Westminster who passed away since our last Annual Meeting.

<u>Moved, Seconded</u> that we accept, as printed (pages 1-7, 2022 Annual Report), the minutes of the Congregational Meeting held on Sunday, February, 20, 2022. (Bill Rankine, Bonnie Evoy) Jeanne moved on to the Nomination Report (p.10, 2022 Annual Report) and Elections. She thanked the council members.

Jeanne pointed out the open spaces on the nomination report and called for additional nominations. She called for nominations from the floor three times. With no additional nominations brought forward, she called for a motion to accept the report.

<u>Moved, Seconded</u> that the Nomination Report is approved and that Council is granted the power to add members to fill the openings as people become available. (Marion Overholt, Brian Stocks)

Jeanne read the names of the Trustees from the 2022 Annual Report.

<u>Moved, Seconded</u> that we reaffirm the members of the Board of Trustees for Westminster United Church are: Dillon Brown, Fred Barkhouse, Jim Kennedy, Bev Marshall, Norm Marshall, Murray Paddon, Julie Swettenham and Rev Del Stewart. (Janet Brown, Sandi McDonald)

Jeanne again pointed out that the names on the nomination report are the representatives to council. Please contact them if you have questions or ideas or would like to help with a particular project.

Jeanne thanked all who contributed written reports for 2022 Annual Report and mentioned that all of them were sent in on time. She thanked Amanda Ballermann for preparing the report. Thanks, too, to Jean Lowden and Rose Barkhouse for proof reading and Amanda and Rose for printing the report which was available last Sunday. Jeanne asked if there were any questions on the reports other than the financial pages.

<u>Moved, Seconded</u> that the reports, with the exception of December 31, 2022 Financial Statements and the 2023 Proposed Budget, are accepted as printed in the 2022 Annual Report. (Bonnie Evoy, Marion Overholt)

## Ministry and Personnel Report - Doug Burt

Rev Del was asked to excuse himself for a short time.

Doug thanked Jeanne, who is the other half of the Ministry and Personnel team. Westminster has two employees, Albert MacDonald and Rev Del Stewart. Albert, who often has help from his sister Cathy, has been a dedicated worker for Westminster for many years. He is often looking after things that need to be

done even though they are not specified in his contract. We are very thankful for the devotion of both Albert and Cathy.

<u>Moved, Seconded</u> On the recommendation of the Ministry and Personnel Committee, that the contract for part-time maintenance and custodial duties with Albert MacDonald will be renewed, ending December 31, 2023. (Doug Burt, Marion Overholt)

The Ministry and Personnel Committee asked Rev Del if he would consider extending his contract with Westminster. Del was interested and after consultation with Wilma, he agreed to continue to serve Westminster.

<u>Moved, Seconded</u> On the recommendation of the Ministry and Personnel Committee, that the contract for the position of part-time Minister with Rev Del Stewart will be extended until June 30, 2024. (Doug Burt, Sandi McDonald)

Doug went to ask Del to return to the meeting.

Doug thanked both Del and Wilma for agreeing to stay on another year. He thanked Wilma for her involvement in our church life, for being part of the family and for her support.

## Trustees Report – Jim Kennedy

Insurance premiums, a perennial topic, have once again increased. Jim worked to tweak the renewal. In 2023, the United Church of Canada opened application to their self-insurance plan. They also lifted the requirement of a replacement value appraisal. Westminster United Church will be submitting an application for a cost quote.

A number of years ago, several excess pews were removed from the sanctuary. These have been stored in the upstairs room. Jim and Fred have measured, recorded and photographed these pews. The plan is to put them up for sale. Please spread the word. We would like to find a new home for this beautiful wood.

In answer to some questions raised, Jim stated that the current insurance company set the replacement value of the church at over seven million dollars. When the UCC started their self-insurance one of the requirements to apply was to provide a current replacement cost appraisal. Jim was quoted \$2500.00 (twenty-five hundred) for the cost of a new appraisal.

## What's Ahead

On Sunday April 16, 2023, we will hold our official celebrations for the 100<sup>th</sup> (one hundredth) Anniversary of Westminster. Rev Lexie Chamberlain will return and speak at this special service of worship. Rev Paul Currie has also been invited to attend. There will be a luncheon in the Friendship Centre with food prepared by the Caboto Club. There will be a cost associated with the luncheon but cost will not be a barrier to attend.

Del reminded everyone to submit their baby pictures for the "Who's Who" guessing game.

The committee is requesting contact information for past members and friends of Westminster. They are preparing an invitation to send out.

At this point we reached quorum.

Jeanne read all of the motions that were made and seconded earlier in the meeting. They are as follows,

## Correspondence – Jeanne Stocks

We have received letters of appreciation from many of the organizations to which we send Canshare donations throughout the year, goods from the rummage sales, the "Red Basket" projects, Mitten Tree donations, and Toys.

In December, 2022, Westminster received a letter from Central United Church requesting a meeting to discuss the possibility of their congregation joining ours. They are winding down and selling their building. In early January, 2023, Westminster representatives met with Central representatives. It was a good

meeting, sharing thoughts and goals. Central was also meeting with other United Churches to find the best fit for their congregation. The congregation of Central has since decided on another location.

#### Finance Report – Fred Barkhouse

Jeanne expressed our thanks to Fred. He is a committee of one. As she has said in the past, Jeanne thinks he has some sort of crystal ball to help him plan budgets.

Fred began his presentation pointing out that the offering total was higher than the budget projection. "Thank you, thank you, thank you!"

The yearend balance sheet is found on page 24 of the 2022 Annual Report.

<u>Moved, Seconded and Carried</u> that the December 31, 2022, balance sheet and accompanying statements of revenue and expenses be accepted as printed on pages 24-26 of the 2022 Annual Report.

Fred prepared the proposed 2023 budget to present to council at their January meeting. Council approved recommending it to the congregation and Fred submitted it to be printed in the 2022 Annual Report. You will find it on pages 27-29. Since that time several things have arisen which have caused Fred to re-think the budget proposal that you see in the report. Fred distributed copies of a new revised budget proposal. It was decided the best way to handle the situation was to address the proposed budget in the Annual Report and then amend things.

<u>Moved, Seconded and Carried</u> that the Proposed 2023 Budget, printed on pages 27-29 of the 2022 Annual Report, be approved as printed. (Fred Barkhouse, Carol Burt)

Fred listed the things that had changed in the last three weeks which made him feel it was necessary to revise the 2023 proposed budget.

First there was the Enbridge bill in excess of \$6600.00 (six thousand, six hundred dollars). Fred did some research because this bill was based on estimated usage and he thought it might have been grossly over estimated. He found that it was somewhat higher than the previous year usage in the same time period but the amount due was mainly due to gas cost increases. He decided the budget needed to be further increased to reflect this so (under property-Enbridge) he added \$2,000.00 (two thousand dollars).

Since the requirement for a new appraisal was lifted, he removed that amount from the budget (under Trustees).

A request from the Anniversary Committee was received. This is addressed in the revised budget proposal (under Pastoral Care).

Last Friday, the church received a letter from Enwin Utilities. Westminster must replace the hydro service coming into the building by April 13, 2023. Enwin has deemed the existing equipment out dated. Fred and Doug have met with two electrical contractors. Fred has not yet heard back from the first contractor. The second contractor still needs to prepare a quote but offered a guesstimate of \$10,000.00 (ten thousand dollars). Fred has added this amount to the revised proposal (under property and maintenance). We are arranging a third quote still to be scheduled.

The United Church of Canada has a grant program for modernization projects. If this work meets criteria, Westminster could receive up to \$5000.00 (five thousand dollars) through this grant program. We will be making an application to the program.

Enwin is also coming in to change the current meters on Tuesday, February 28, 2023.

Moved, Seconded and Carried that the revised 2023 budget be accepted as presented. (Fred Barkhouse, Marion Overholt)

Some questions were asked and answered including what was included under Fund Raising and were there other property maintenance issues.

Fred will keep the congregation apprised on progress with the hydro service.

There were comments about unused rooms in the building and the possibility of renting the space. We have space listed on our website and there have been some inquiries but no takers. In the past, the groups who used space here heard about it through friends or members of the congregation. If you know of someone looking for office space or event space, please pass on the Westminster information for them to consider.

It was also suggested that since our bills are all higher it may be time to ask the groups who are already using space here to give a little more.

There was some discussion about promoting PAR (pre-authorized remittance) for the offering. Westminster is fortunate in that most of our people are very diligent about "catching up" their offering if they miss a week or go on vacation. We have members who faithfully send their offering to the church even when they are not attending due to the pandemic or other factors. PAR is also an option to ensure your chosen amount is sent to the church every month.

Again, we thank Fred for his work, for keeping up to date by attending finance webinars and for applying for grants on our behalf.

## **Other Business**

Jeanne informed us that the piano tuner says the chancel piano is on its way out. Michael Oddy has also observed it is not going to last much longer. It is in need of a very expensive repair. Michael is working around the problem. If anyone knows of someone who would like to donate a baby grand in good condition to Westminster, please let it be known that we are in need of a new piano. A good, concert quality piano purchased new would likely cost in the neighbourhood of \$200,000.00 (two hundred thousand dollars).

Del thanked the congregation for their support of the motion to extend his contract to serve at Westminster for another year. He truly enjoys being here.

Thank you all for your attendance and participation.



## **MESSAGE FROM THE MINISTER**

Hello Westminster folk:

As you know, it's customary for the minister to share his/her thoughts in the Annual Report by reviewing the past year, and then suggesting some possibilities for the congregation's future.

This year I've decided to resist the temptation of doing the traditional 'annual review' followed by some theoretical 'looking ahead' scenario. Instead, I'm sharing with you the simple but beautiful and powerful poem "Seeing God" written by Brother Jonathan Gardner. This poetry gracefully reflects what the God of Jesus, and our God, calls us to be and to do.

I submit this brief composition in humble and sincere gratitude for the opportunity of serving Westminster United Church throughout the past year.

"Seeing God" – a poem by Brother Jonathan Gardner

I saw God today as I left the train. A teenager helped a stranger carry a shopping bag. He took the strain.

I saw God today, as I walked into the mall. I saw a beggar get coffee from a man, and some bread. He was there when that homeless guy needed a pal.

I saw God today, as I walked out of the post office. There was an argument between two women in the street. A third intervened, and all was at peace.



I saw God today, as I watched a house ablaze on the tv news, the situation dire. They said a young boy, a hero, had dashed in and rescued a baby. And saved her from certain death in that huge fire.

I saw God today. A neighbour was lonely and needed to speak. And someone took the time to stop and listen. And share some pastries, and give them a break.

I saw God today, as I rented a car. The person behind the counter was as polite as could be. They smiled, took an interest, and lifted my spirits.

## ANTLER RIVER WATERSHED REGION – REPRESENTATIVE REPORT

Antler River Watershed Region met twice in 2023, once in May and again in October. The May meeting was a hybrid meeting held in London. Hybrid meaning in-person and zoom; I chose to attend via zoom to save on expenses and time. The October Meeting that I missed was a zoom meeting only, but I watched the recording. I was able to receive information but not participate in the discussion or vote on the remit for autonomy for the Indigenous Church of the United Church of Canada. The representatives attending the meeting voted in favour of the remit. As of the writing of this report, the council of Westminster has not voted on the remit and has until March 31, 2024, to do so and submit the results. Any community of faith in the United Church who does not vote will be considered a "no" vote. There was a report of several communities of faith closing or amalgamating and a church camp has closed as well. There are several communities of faith that have decided not to hire a minister going forward; therefore, there is a greater need for Supervisors in the region. The

supervisors are needed so that a community of faith can conduct "business" meetings in accordance with the "Manual".

I have participated in several zoom meetings and webinars conducted by the region as well. Topics ranged from Supervisors for communities of faith being paid to duties of the Supervisor, as well as a zoom meeting about grants to reduce our church's carbon footprint. There have also been webinars by guest speakers; one in particular was on the bible and people with disabilities.

There will be a tri-regional meeting between Antler River Watershed, Western Ontario Waterways and Horseshoe Falls Regions on May 24-26, 2024, at the Unifor Centre in Port Elgin that I plan to attend. This will be an in-person only meeting.

The tri-region has a new Executive Minster, Rev. Mark Laird, who is replacing Cheryl-Ann Stadelbauer-Sampa who has accepted a position on General Council.

## **PROPERTY AND MAINTENANCE**

2023 proved to be a rather busy year for the Westminster Property volunteers. Due to the age of our building, problems continue to appear.

Regular building inspections and maintenance were carried out by Fred Barkhouse, Garry Derbowka, Jim Kennedy, Julie Swettenham and Doug Burt. Fred continues to ensure that snow is taken care of over the winter months and Garry maintains the outdoor areas over the summer.

We do want to thank our Custodian Albert MacDonald and his sister Cathy for their support and a willingness to help whenever called upon. This past year Albert did spend extra time in the building when there were problems with the furnace.

In March, we learned that the boiler had broken and sunk into the floor of the furnace room and it was deemed unsafe and could not be used until it was repaired. Fortunately, it was able to be repaired by placing a steel plate under it and welding the frame. Needless to say, this was a rather large unexpected

expense. In November, there were further issues with the heating system. These also were repaired.

The team has replaced many of the old incandescent light bulbs with energy efficient LED light bulbs.

Last summer, rather heavy rains caused a flood in the elevator shaft on two occasions requiring clean up. Fortunately, no damage was done to the electrical. Clean up was taken care of by Albert, Cathy, Jim, Julie and Doug and the foundation was sealed around the elevator building street level.

Repairs were completed by Fred and Doug to a plugged downspout on the Tecumseh side of the building which caused flooding in a downstairs classroom. Doug did repairs to the window and repainted the inside wall. Fred and Doug also replaced the sinks in the Friendship Centre ladies' bathroom. As well, they updated some of the electrical switches and plugs located in the Friendship Centre.

As always, we ask if you note an area of concern in the building, please make us aware.

Our float of \$40.50 was donated to the Westminster general fund in January 2024. There were five quilts remaining for sale at the end of 2023.

## A Brief History of the Westminster Crafters/Quilters.

In the fall of 1986, eight women decided they wanted to learn to quilt and make crafts. They were proud to call themselves the "Westminster Crafters". Under the leadership of Martha "Mattie" Taylor, they learned to quilt and they also created crafts to sell at the annual bazaar.

Because the women were no longer making very many crafts and were concentrating on quilting, the name was changed in 1994 and they became the "Westminster Quilters".

I was welcomed by the Quilters in 2000. On Tuesday mornings, we quilted on the stage in the Friendship Centre and needed at least two quilts on the frames to accommodate all the quilters. I remember many wonderful women who were part of the group at that time: Mattie Taylor, Grace Arnold, Laurice Mellanby, Nora Reid, Ethel Buchanan, Eva Brown, Helen Ramey, Jean Johns, Joy Bull and Margaret Green were among them. We quilted both queen-sized whole cloth quilts and baby quilts. As our numbers decreased over the years, we stopped making the larger quilts but continued making baby quilts. Joy Bull was keeping the records and asked me to take over that task. I started photographing our quilts in 2006. Amanda Ballermann and Carol Burt joined the quilters. Later, Amanda found fulltime employment and was unable to continue quilting with us. We have had some part-time quilters and guest quilters over the years. There was always lots of interesting conversation and caring support amongst the group.

In 2020, only three quilters remained but we were still actively quilting. Due to mobility issues and accessing the stage, we had moved our quilt frames into the Sanctuary. Then COVID-19 shut everything down. Because we had some quilt supplies in our "stash" the quilters each brought one project home to work on until we could resume. Due to health issues and injuries and other things our small group was not able to resume and at the end of 2023 we decided to end the Westminster Quilters. We miss our time together but still keep in touch over the phone and by email.

## TREASURER

I set an ambitious goal in the 2023 budget, the year of our 100<sup>th</sup> anniversary. The goal for our envelope and PAR collection was \$70,000.00. I am happy to announce that the goal was met. Congratulations to all members of Westminster both near and far, and thank you for your continued support. Fund raising goals and events exceeded expectations as well.

Our deficit was lower than anticipated but there were still some surprises. The church's heating system needed some more repairs this fall, even after some major work in the fall of 2022. A big thank you to Power House for their generous donation of time and materials in 2023. There was one exception to the expense side of the budget that went over budget: heating the building. Even with no heat for nearly three weeks in the fall of 2023, it still went over budget nearly \$100.00 (One Hundred Dollars). There were some realized savings in the church's insurance costs.

Utilities, insurance and salaries (not necessarily in this order) are the church's three major expenses. Hopefully, repairs to the heating system in 2024 will be minimal.

I have tempered the church's goal for income to a similar amount in 2024 to what it was in 2023. This seems realistic to me looking forward. I see new and enthusiastic faces joining the congregation on Sunday mornings and helping at events. Unfortunately, we also must remember that we lose members through various means as well.

Thank you for a very successful 2023 and let's look forward to a great 2024, our 101<sup>st</sup> year.

## TRUSTEES

#### **Trustee membership**

The focus for 2023 was on managing the ever-increasing cost of property and liability insurance.

## Insurance

We have had little success finding alternatives to our current insurance policy brokered through All-Risks. Over a year ago, an alternative provider denied coverage to Westminster due to the age of our building.

This year, we applied for UCC's self-insurance (HUB) program but encountered two compliance challenges that stopped us from proceeding with them. First, all applicants must follow the UCC's policy of conducting mandatory background checks for employees and volunteers. Westminster does not routinely undertake such checks for volunteers. Second, applicants must include recent inspection reports from a licensed electrician and plumber. The cost of inspections had not been included in our 2023 budget. Given the age and condition of the building, we are likely to be non-compliant with certain electrical and possibly plumbing standards, which would be an impediment to going forward with this program.

That left Westminster relying solely on All-Risks. Fortunately, this year's renewal amounted to a 7.5% increase over last year (\$20,155 including PST), and came in under Westminster's budget of \$20,600.

Nevertheless, given the large deficit expected this year, the Trustees considered ways to reduce our coverage and save money. Trustees held a meeting on the matter at which they recommended the removal of the stained glass and pipe organ endorsements from our policy. Council approved the changes at its October meeting. This resulted in a total credit of \$975 (PST included). In the end, our insurance costs for the 2023-24 coverage totalled approximately \$19,180.

Trustees will explore ways to further manage insurance costs, such as reducing the replacement cost of the building to better match future space requirements.

## Pews

The sale of excess pews was mentioned at the Annual Congregational Meeting in February, 2023. We were reminded that Bonnie Evoy had purchased one pew for the nursery and indicated interest in acquiring a second pew.

Other than that, there has been no further action taken on this.

#### Investments

We have renewed all three GICs in the Trustees Fund this year at or close to an annual interest rate of 5%. The total fund balance stands at \$67,405. The Trustees thank Del for his leadership and patience.
