The Foundation operates 4 CrossFit gyms throughout Kauai to provide a safe drug and alcohol free environment for the youth of Kauai. All gyms provide personal mentorship to Kauai's youth so kids know they belong and are loved. Keala trained and mentored over 500 kids this year. We offer 4 classes per day for a total of 16 classes per week that serve kids ages 5-18. Keala launched its first Early Intervention Program for male teenagers with substance abuse. Keala launched an Ocean Safety Program that put 52 kids through Jr. Lifeguard training. Keala offers many weekly activities to all middle and high school students such as tutoring, excursions, camping trips and meditation workouts.

Each year, the Foundation hosts the hugely popular Ultimate Hawaiian Trail Run. This island race is both beautiful and challenging. 1,100 people participated in this years run: 440 kids (free) and 660 adults.
