Parent and Family Engagement Policy

Anthony Middle School agrees to implement the following statutory requirements:

- Consistent with section 1118, the school will work to ensure that the required school level parental involvement policies meet the requirements of section 1118 of the ESSA and each include, as a component, a school-parent compact consistent with section 1118(d) of the ESSA.

- (C) *That parents are full partners in their child's education and are included, as appropriate, in decision-making and on advisory committees to assist in the education of their child;*
- (D) *The carrying out of other activities such as those described in section 1118 of the ESSA.*

1. **Anthony Middle School** will take the following actions to involve parents in the joint development of its school parental involvement plan under section 1118 of the ESSA:

3. **Anthony Middle School** will hold an annual meeting to inform parents of the school's participation in title I, Part A programs, and to explain the title I, Part requirements and the right of parents to be involved in Title I, Part A programs. The school will convene the meeting at a time convenient for parents and will offer a flexible number of additional parental involvement meetings, such as in the morning or evening, so that as many parents as possible are able to attend.  - Flyers/Notices
 - Post in the district website

4. **Anthony Middle School** will provide parents of participating children information in a timely manner about title I, Part A programs that includes a description and explanation of the school's curriculum, the forms of academic assessment used to measure children's progress, and the proficiency levels students are expected to meet by:
 - Parent Teacher Conference
 - Written communication
5. **Anthony Middle school** will at the request of parents, provide opportunities for regular meetings for parents to formulate suggestions and to participate, as appropriate, in decisions about the education of their children. The school will respond to any such suggestions as soon as practicably possible by:
 - Coordinating numerous parental involvement sessions to include needs communicated through parent surveys, parent requests, and principal-parent sessions (Coffee with Principal)
6. **Anthony Middle School** will provide each parent an individual student report about the performance of their child on the State assessment in at least math, language arts and reading by:
 - Mailing individual test results
7. **Anthony Middle School** will take the following actions to provide each parent timely notice when their child has been assigned or has been taught for four (4) or ore consecutive weeks by a teacher who is not highly qualified within the meaning of the term in section 200.56 of the title I Final Regulations (67 Fed. Reg. 71710, December 2, 2002) by:
 - Mailing letters of notice
8. **Anthony Middle School** will provide assistance to parents of children served by the school, as appropriate, in understanding topics by undertaking the actions described in this paragraph—
 - The state's academic content standards,*
 - The state's student academic achievement standards,*
 - The state and local academic assessments including alternate assessments,*
 - The requirements of Part A,*
 - How to monitor their child's progress, and*
 - How to work with educators:*

9. **Anthony Middle School** will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parental involvement, by:

 - Providing access to TxConnect Parent Portal
 - Parent surveys to determine needs
