

SET FEE RATE CARD

Our new client rate card is still based on a set fee policy, but we have integrated below services instead of showing a separate fee to process biometrics support services. Unless otherwise confirmed, our main support fee will cover the following services:

What is covered in our firm set fees:

- ✓ Pre-client care letter assessment (unless complex case then a separate fee applies, see items 3 and 4 below).
- ✓ Client care letter explaining their application, visa options, any issues, data sharing, family and invoicing terms.
- ✓ Register the clients Home Office application portal using a unique client email account.
- ✓ Processing the client's online application form.
- ✓ Submitting the clients Home Office application form and processing any payments.
- ✓ If applicable booking the clients biometric appointments.
- ✓ Preparing and formatting the clients document evidence and upload to the Home Office or service provider portal.
- ✓ Preparing the client application support letter.
- ✓ Emailing the client any Home Office or service providers communication.
- ✓ Closed client letter.

What is not covered in our firm set fees:

- ✗ Home Office fees or immigration health surcharge charges.
- ✗ Home Office service point or any other associated commercial partner fees.
- ✗ Paying for any special delivery or courier service to deliver documents to the clients UK address.
- ✗ Paying for shipping documents to overseas addresses.
- ✗ UK sponsors costs such as study or work visas.

AR If the client requires our firm to help them submit an administrative review (AR), we will charge a set fee for this service. Our firm provides 3 levels of business plan support that covers template only to fully writing the plan.
