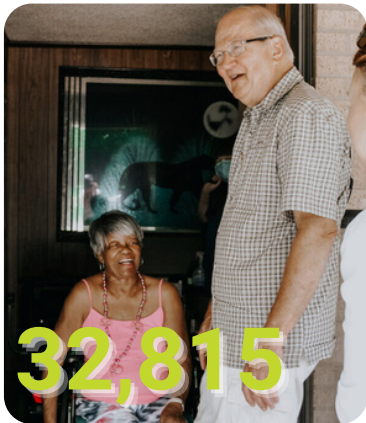

Councils of Governments (COGs) are political subdivisions created under Texas Local Government Code, Chapter 391 to improve the health, safety, and general welfare of residents and to plan for future development.

We are one of 24 COGs in Texas, serving as the bridge between federal, state, and local governments, providing the services and support our communities need to grow and thrive.

- Formed in 1970, ETCOG consists of more than 140 member governments and organizations that represent the people of our 14-county region – Anderson, Camp, Cherokee, Gregg, Harrison, Henderson, Marion, Panola, Rains, Rusk, Smith, Upshur, Van Zandt, and Wood counties.
- ETCOG is governed by local elected officials through its Board of Directors and Executive Committee. Many policy and advisory committees assist ETCOG and its boards in taking beneficial actions for all in the region.

How is ETCOG Funded?

COGs primarily receive funding through state and federal grants but also receive funding from local sources, such as our membership dues. These dues assist in grant matching requirements, helping draw more funding to East Texas.

With local elected official guidance and consent, ETCOG administers grants for four primary service areas: Workforce and Economic Development, Area Agency on Aging, Public Safety, and Transportation.

\$86 Million Budget

ETCOG has a balanced budget of \$86M to address regional issues and opportunities in FY 2026. Nearly 75% of the funds received go directly back into East Texas through grants, services, and program administration.

In addition to an independent audit, our agency is regularly monitored and audited by our funders. We're proud to report ETCOG has received the Certificate of Achievement for Excellence in Financial Reporting for 24 consecutive years!
