# What we do and why we are different from a traditional funeral home.

Alpha-Omega is an alternative option to a traditional funeral home. We offer the basic services for burial or cremation. Alpha Omega does not have the facilities that a full service funeral home does; however we can contract with a local funeral home to provide those requested services.

We operate Alpha-Omega with very little overhead. We have an office to make arrangements for burial or cremation. We provide very simple and basic services, without a large facility and numerous staff.

# **Itemized Selections**

#### Basic Service of Funeral Director and Staff

\$695.00

Our fee for the basic services of funeral director and staff includes, but is not limited to, staff to respond to initial request for service; arrangement conference with family and responsible parties; arrangement of funeral; preparation and filing of necessary authorizations and permits; recording vital statistics; preparations and placement of obituary notice; and coordination with those providing other portions of the funeral; e.g. cemetery, crematory, vault company and others as required. Also included in this charge are overhead expenses relative to our facilities such as professional licensing, legal and accounting fees, insurance, building and utility expense, parking lot and grounds maintenance, taxes, equipment, furnishings, record keeping and administrative expenses.

This fee for basic services and overhead will be added to the total cost of the funeral arrangements you

select. (This fee is already included in our charges for Direct Cremation, Immediate burial, forwarding and receiving and other service packages.)

Alternative containers encase the body and can be made of material like fiberboard or composition materials. The containers we provide are unfinished wood boxes and fiberboard boxes.

Our charge for immediate burial includes removal of remains, basic service of staff, necessary authorizations, and casketing of remains. This charge does not include the use of facilities and staff for any visitation or ceremony prior to burial.
