## **Federal Trade Commission (FTC) Disclosure**

The Federal Trade Commission (FTC) and the New York State Department of Health both require that certain disclosures be made by funeral providers on the General Price List. Although these disclosures are similar, they are not exactly the same. This General Price List contains both sets of the required disclosures. The disclosures required by the FTC, when different from those required by the Department of Health, are preceded by the letters "FTC."

"FTC" The goods and services shown below are those we can provide our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our services. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral services and merchandise you selected.

"FTC" This list may not include prices for certain items that you select, such as cemetery charges or crematory services, flowers, and newspaper notices. The estimated or final prices for those items will be shown on the itemized statement describing the funeral services and merchandise you selected. We charge you for our services in buying certain items.

## **New York State Disclosure**

The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our services. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

This list does not include prices for certain items that you may ask us to buy for you, such as cemetery or crematory services, flowers, and newspaper notices. The estimated or final price for those items will be shown on the itemized statement describing the funeral services and merchandise you selected. We charge you for our services in buying certain items. The prices for those items will be shown on your bill or the statement describing the funeral goods and services you selected.

## **For Funeral Payment Options The Following Choices Are Available:**

1. **Payment in full at the time of arrangements.**
  - Cash
  - Check
  - Credit or Debit Card (*Visa, MasterCard, American Express or Discover*)
2. **A minimum down payment of 50% is required by the day prior of the funeral service, with the balance to be paid within thirty days.** This minimum down payment is also required if expenses are to be paid from the proceeds of an insurance policy or through the settlement of an estate.

**NOTE:** After thirty days, a late charge of 1.33% per month (16% per year) will be added to the unpaid balance.

3. **Insurance assignment to funeral home.**

**NOTE:** Cash advance items **will not be included** in the insurance assignment.

## **Funeral Payment Requirements:**

**Cash Advances** (Services and merchandise provided as cash advance items will be paid by the family.)

**All cash advances to other parties must be paid by the day prior to the funeral.**

**Cash advances would include:** Cemetery Expenses. Crematory Charges, Death Certificate Copies, Church Fees, Clergy Honorariums and Musician Charges or Bagpiper.

## **Newspaper Notices**

All notices must be paid by credit card at the time the obituary is submitted.

In New York State, embalming is not required by law. If you do not want embalming, you have the right to choose an arrangement which does not require you to pay for embalming such as direct cremation or direct burial. If you select certain funeral arrangements, such as a viewing or an open casket funeral, embalming is required by the funeral home.

**OTHER PREPARATION OF REMAINS**

*(Excluding Embalming)*

Preparation of the remains, unless selected, is not required for direct cremation or for direct burial.

1. **Topical Disinfection** (including use of preparation room) ..... \$300.00
2. **Custodial Care** (charged per day after 24 hours).....\$60.00  
NOTE: "Custodial Care" will not be charged on the days when embalming or other preparation of the remains occurs, visitation is held, or a funeral service is conducted.
3. **Dressing/Casketing**..... \$150.00
4. **Cosmetology**..... \$150.00

**ARRANGEMENTS**

The charge for our services will be added to the total cost of the funeral arrangements you select. However, this charge will not be added to the cost for direct cremation, direct burial, forwarding of remains, or receiving of remains because the prices for those services include this charge.

**LIMITED SERVICES**

**FORWARDING REMAINS TO ANOTHER FUNERAL HOME**

This charge includes basic transportation of the remains to the funeral home, other necessary local transportation of the deceased by livery, required authorizations, services of funeral director and staff and necessary use of facilities. Transfer or other transportation by funeral home livery beyond the radius of 10 miles is subject to an additional charge of \$3.75 per mile. Transportation by common carrier is not included in the above charge. .... \$2,225.00

**RECEIVING REMAINS FROM ANOTHER FUNERAL HOME**

This charge includes basic transportation of the remains to the funeral home, other necessary local transportation of the deceased by livery, required authorizations, services of funeral director and staff, and necessary use of facilities. Transfer or other transportation by funeral home livery beyond a radius of 10 miles is subject to an additional charge of \$3.75 per mile. Transportation by common carrier in not included in the above charge..... \$2,225.00

Transportation beyond a local place of disposition will be billed as livery charges. Local place of disposition is up to 10 miles.

**ALTERNATIVE SERVICES**

The following charges for direct cremation and direct burial shown below include ONLY the items in the following descriptions.

**DIRECT CREMATION:**..... \$2,825.00

Our charge for a direct cremation includes local transfer of remains to funeral home, required authorizations, services of funeral director and staff, transportation of the body by livery to local crematory and the return of the cremains to the funeral home. Transfer or other transportation by funeral home livery beyond a radius of 10 miles is subject to an additional charge of \$3.75 per mile.

If you want to arrange a direct cremation, you may use an unfinished wooden box or an alternative container. Alternative containers can be made of heavy cardboard, pressed wood or composition materials.

**NOTE: The direct cremation price DOES NOT INCLUDE the crematory fee or the alternative container.**

**DIRECT (IMMEDIATE) BURIALS:** .....\$3,185.00

Our charge for an immediate burial includes local transfer of remains to the funeral home required authorizations, services of funeral director and staff, transportation of the body by livery to local area cemetery. Transfer or other transportation by funeral home livery beyond a radius of 10 miles is subject to an additional charge of \$3.75 per mile. NOTE: The direct burial prices do not include the cemetery charges.
