Following the Call for Abstract Deadline, all abstracts will be made anonymous prior to review by the 2026 RMIA Risk Conference Program Committee.

The abstract review period will be three weeks. The Conference Chair serves as the head of the 2026 RMIA Risk Conference Program Committee and will make the final decisions for abstracts. If a revision is required, the revised abstract must be sent back within a week. Following the review period all of those who submitted an abstract will be notified via email as to the status of their submission.

Submission Instructions

- Once you have finished entering all details, please ensure you proceed all the way to the end to COMPLETE your submission. Otherwise, your abstract will not be reviewed.
- Amendments can be made to your abstract until the submission deadline. Simply log into your Currinda profile, select the abstract to amend and navigate through the top tabs to the sections you wish to change.
- An automatic acknowledgement email will be sent once your abstract submission is complete.
- Please note that the title must not be written in all caps, but in sentence case only.

Guidelines

Abstracts must meet the following guidelines to be considered:

- Abstracts must be submitted in English.
- The abstract should be no more than 300 words.
- The abstract should include the following:
 - Title of proposed presentation
 - Abstract or proposed presentation with careful consideration of how it fits in with the theme of 'Risk Drives Everything'.
 - Full name, job title and organisation of proposed presenter/s
 - Bio of proposed presenter/s
 - You can upload supporting documents or images if required, but these must not be the abstract itself.

RMIA

- Presentations at the RMIA Risk Conference will be for either 30 or 45 minutes, this
 includes a 2 minute introduction by the Chair and 5 minutes for your wrap-up and
 Q&A.
- All abstracts that have been submitted recently to other congresses / conferences should not be submitted here. If your abstract is on a subject you have presented at a previous RMIA Risk Conference, it must focus on new developments since then.
- You can return and edit your abstract at any time before the submission end date of Monday, 09 February 2026.
