1. INTRODUCTION

Buffalo Urban League, Inc. is seeking sealed bids from qualified resellers of the Verkada Security Solution to perform internal and external security monitoring at 15 Genesee Street, Buffalo, New York 14203. The selected bidder must comply with all applicable federal, state, and local laws, including New York State procurement, labor, and safety regulations, OSHA Safety Standards, and the New York State Building and Energy Code.

2. SCOPE OF WORK

- Video Surveillance: Comprehensive outdoor coverage with a two-device setup (dome + telephoto bullet) for extended person detection range in the rear parking lot. Interior cameras will use the CM42 models.
- Access Control: Reader-only installation at entry points with a modern card/phone tap system.
- Intercom: TD33 intercom at the main entrance.
- Alarm System: Installation of an alarm panel and keypad.

3. BIDDER QUALIFICATIONS

To be eligible, bidders must:

- Be **licensed and insured** to perform installation work in New York State.
- Demonstrate at least **three (3) years** of experience with similar security solution projects.
- Provide three (3) references for similar projects.
- Authorized reseller of Verkada products.
- Provide a certificate of insurance meeting the following minimum coverage:

o General Liability: \$1,000,000

Workers' Compensation: \$1,000,000

Professional Liability: \$1,000,000

- Experience and qualifications (20%)
- MWBE participation plan (5%)
