## **TERMS AND CONDITIONS**

- 1) All prices exclude VAT at 15% and include delivery within 50km radius.
- 2) This offer is valid for fourteen days from the date of quotation and is subject to credit approval. Due to the fluctuations in **foreign currency exchange** and import duty we reserve the right to adjust prices accordingly. Any such adjustment before delivery would need to be passed on to the client. Rate of exchange being as per quotation Summary of Fees, any variation to be applied at time of landing. Should you wish to purchase forward cover, kindly complete the attached Exchange Rate Variation form.
- 3) In order to facilitate the financing of the quoted equipment for FMR and Extended Purchase, our finance partners will require the following upon placement of order:
  - Signed A Square Sales Order
  - Official Purchase Order
  - Completed and signed Application Form
  - 2 Years of audited Financial Statements
  - Upon approval, contracts will need to be signed prior to order being placed with our overseas principals.
- 4) Delivery subject to availability at receipt of official purchase order. Expected delivery dates are given in good faith. We shall at all times endeavour to ensure that these times are met. No liability can, however, be accepted for unforeseen delays, neither for consequential damages incurred by these delays.
- 5) Rental, Extended Purchase and FMC rates basis **includes hours per month as stated**. For excess usage an excess hour rate per hour overtime is applicable to cover additional wear and tear, maintenance and reduced residual value.
- 6) Exclusions: Drivers, fuel, top up oil or water, insurance, replacement tyres, replacement forks, abuse and damage due to accidents.
- 7) Cleaning Equipment Exclusions: Squeegee blades, wiper blades, skirts, curtains, bumpers, filters, screens, vacuum bags, brooms, brushes, pads and retainers, rubber floor seals and retainers, hoses, squeegee wheels, caster wheels, tyres and vacuum motors with evidence of moisture or debris intrusion.
- 8) Rental and Extended Purchase rates on electric units include battery and charger for the full rental period. The client shall have no replacement liability of battery cells for the period abuse of battery excluded, subject to signing a full maintenance contract on the battery. Battery maintenance excludes replacement of consumables or wear and tear items, including cell connectors, cables and plugs.
- 9) Traction batteries carry a four-year pro-rata warranty as backed by the manufacturer abuse excluded. On outright purchases with a battery maintenance contract, this warranty can be extended to a full five (5) year warranty or 1500 charge cycles abuse excluded.
- 10) Rental and Extended Purchase units must be insured. We are able to provide the necessary cover and a quotation is available on request. Should you wish to self-insure, we would require the relevant documentation for our records. The client is responsible for any excess on claims.
- 11) Rental and Extended Purchase rates include a full maintenance programme. This involves routine servicing at the correct intervals according to the manufacturer's specification, as well as immediate response to breakdowns. Should a major breakdown occur which can not be resolved on site, a temporary replacement unit from our short-term rental fleet will be placed until such time as that the machine is fully repaired.
- 12) Rental and Extended Purchase rates linked to the ruling prime interest rate.
- 13) Rental, Extended Purchase, PMA and Full Maintenance Contract rates subject to annual escalation.
- 14) The client will retain ownership of the forklifts at the end of the Extended Purchase period upon payment of 1% (excl. VAT) of the initial capital value and provided all due amounts have been timeously settled in full.
- 15) Rental and Extended Purchase payments due monthly in advance by bank debit order. Should the debit order be returned as unpaid, an invoice will be raised to recoup such costs.
