If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

Warranties

Our Funeral Establishment makes no representation of warranties about the protective value of certain caskets or outer burial containers other than those made by the manufacturer. Charges for Services Selected

1. Professional Services

Basic Services of

Funeral Director & Staff

The fee for our professional services will be added to the total cost of the funeral arrangement you select. (This fee is already included in our charge for church or chapel funeral packages and immediate burial.) This is a basic fee that we charge every family for our professional expertise in assisting them with their preferences.

Our charge includes, but is not limited to:

- A proportionate share of taxes, licenses, utilities and business expenses required to serve the public.
- Personnel available 24 hours a day, 365 days a year to respond to the initial call for service.
- Consultation with the family, to discuss with you and for implementation of desired arrangements, consultation with the clergy, cemetery, crematory or common carrier, planning the funeral or memorial service, and direction & supervision of the services as determined by the family.
- Administrative and clerical services, preparation of the death certificate for certification by the attending local physician or local coroner, preparation of local necessary local permits, filing of the death certificate with the appropriate local government agencies.

Expedited Funding & Claims Processing Service

A third-party insurance policy (NOT purchased through a Parkview Mortuary Insurance provider) may be used as a pending form of payment. A processing fee of 3.5% of the contract total will be added for expedited funding. Additional Terms and conditions may apply.

Refrigeration (Up to 7 Days)

California law requires a funeral establishment to refrigerate after 24 hours.

Embalming

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.
