GENERAL PRICE LIST

These prices are effective as of August 28, 2025 and are subject to change without notice.

The Federal Trade Commission (FTC) and the New York State Department of Health both require that funeral providers on the General Price List make certain disclosures. Although these disclosures are similar, they are not exactly the same. This General Price List contains both sets of the required disclosures. The disclosures required by the FTC, when different from those required by the Department of Health, are preceded by the letters "FTC."

(FTC) "The goods and services shown below are those we can provide our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our services. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral services and merchandise you selected."

(FTC) "This list does not include prices for certain items that you may ask us to buy for you, such as cemetery charges or crematory services, flowers, and newspaper notices. The prices for those items will be shown on your bill or statement describing the funeral goods and services you selected."

ALTERNATIVE SERVICES:

The following charges for direct cremation and direct burial shown below include **ONLY the items listed in the following descriptions:**

DIRECT CREMATIONS:

Range of Prices: **\$2,550 to \$8,855.00**

Our charges for direct cremation (without ceremony) includes local transfer of remains to funeral home, required authorizations, minimum services of funeral director and staff, transportation of remains by livery to local crematory, and return of the cremains to the funeral home. Transfer or other transportation by funeral home livery beyond a radius of 30 miles is subject to an additional charge of \$3.00 per mile.

If you want to arrange a direct cremation, you may use an unfinished wooden box or an alternative container. Alternative containers can be made of heavy cardboard, pressed wood or composition materials (with or without an outside covering) or may be pouches of canvas or other materials.

*Direct cremation prices **DO NOT** include the crematory charge.*

DIRECT (IMMEDIATE) BURIALS:

Range of Prices: **\$3,140 to \$9,735.00**

Our charges for immediate burial include local transfer of remains to funeral home, required authorizations, services of funeral director and staff, transportation of the remains by livery to local area cemetery. Transfer or other transportation by funeral home livery beyond a radius of 30 miles is subject to an additional charge of \$3.00 per mile.

*The direct burial prices **DO NOT** include cemetery charges.*

PREPARATION OF REMAINS:

Embalming (including use of preparation room) \$795.00

Embalming of Autopsied Remains \$995.00

In New York State, embalming is not required by law. If you do not want embalming, you have the right to choose an arrangement, which does not require you to pay for embalming such as a direct cremation or direct burial. If you select certain funeral arrangements, such as viewing or an open casket funeral, embalming may be required by the funeral firm.

(FTC) "Except in certain special cases, embalming is not required by law. Embalming may be necessary, however; if you select certain funeral arrangements, such as a funeral with a viewing. If you do not want embalming, you usually have the right to choose an arrangement which does not require you to pay for it, such as direct cremation or immediate/direct burial."

OTHER PREPARATION: (Including use of the preparation room, but excluding embalming)

Preparation of the remains, unless selected, is not required for direct cremation or for direct burial.

1. Topical Disinfection \$125.00

2. Custodial Care (*charged per day 48 hours after transfer is made*) \$75.00

Custodial Care will not be charged on the days when embalming or other preparation of the remains occurs, visitation is held, or a funeral service is conducted.

3. Dressing/Casketing \$120.00

4. Cosmetology \$120.00

5. Restoration \$100.00/hr.

6. Refrigeration of Unembalmed Remains – per day or portion thereof \$75.00

ARRANGEMENTS:

The charge for our services will be added to the total cost of the funeral arrangements you select. However, this charge will not be added to the cost for direct cremation, direct burial, forwarding of remains, or receiving of remains, because the prices for those services include this charge.

(FTC) "This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)"

The charge for basic arrangements shall include: *services of the funeral director, other staff, equipment and facilities to respond to initial request for service, the arrangement conference, securing of necessary authorizations, and coordination of service plans with parties involved in the final disposition of the deceased.*

FORWARDING REMAINS TO ANOTHER FUNERAL HOME \$2,495.00

This charge includes local transfer of remains to funeral home, other local transportation of the deceased by livery, required authorizations, minimum services of funeral director and staff, and necessary use of the facilities. Transfer or other transportation by funeral home livery beyond a radius of 30 miles is subject to an additional charge of \$3.00 per mile. Transportation by common carrier is not included in the above charge.

The above charge DOES NOT include embalming, topical disinfectant, shipping charges or additional items of services, merchandise, or a minimum-shipping container that the customer may wish to select.

RECEIVING REMAINS FROM ANOTHER FUNERAL HOME

\$2,495.00

This charge includes local transfer of remains to funeral home, other local transportation of the deceased by livery, required authorizations, minimum services of funeral director and staff, and necessary use of the facilities. Transfer or other transportation by funeral home livery beyond a radius of 30 miles is subject to an additional charge of \$3.00 per mile. Transportation by common carrier is not included in the above charge.

The above charge DOES NOT include shipping charges or additional items of services, merchandise, or a minimum-shipping container that the customer may wish to select.

ANATOMICAL GIFT (Body Donation)

\$1,895.00

This charge includes local transfer of remains to funeral home, transfer of remains to recipient's facility, basic services of funeral director and staff, and required authorizations. Transfer or other transportation by funeral home livery beyond a radius of 30 miles is subject to an additional charge of \$3.00 per mile. Transportation by common carrier is not included in the above charge.

The above charge DOES NOT include merchandise, use of facilities for viewing or ceremony or any other items the customer may wish to select.

CASH ADVANCES:

Services and merchandise provided as cash advance items will be billed at the same amount paid by the funeral firm. These include, but are not limited to:

1. Cemetery and/or crematory charges
2. Death certificate transcripts
3. Clergy Honoraria, Organist, Soloist, Sexton, Cantor, Bag Piper, or Church Charges
4. Winter Storage/Additional Spring Burial Charges

8. Hairdressing
9. Death Notice in Newspaper
10. Limousine/passenger car

CONTAINERS PROVIDED BY PURCHASER

Containers provided by purchaser must carry Liability Insurance and hold harmless agreement, releasing the funeral home from any liability, should a failure occur causing injury, mental or physical, to any persons including but not limited to: funeral home personnel, members of the bereaved family, cemetery, or crematory personnel. The provider shall also be held liable for any/all attorney fees and court costs pertaining to the fore mentioned items, should the funeral home have any cause to pursue a legal recourse. Our funeral home requires a signed release indicating that the provider shall not hold the funeral home liable for any structural defects, or substandard construction.
