However, any funeral arrangements you select will include a charge for our services. If legal or others requirements mean you must buy any items you did not specifically ask for, we will explain a reason in writing on the statement we provide describing the funeral services and merchandise you selected.

This list may not include prices for certain items you select, such as cemetery charges or crematory services, flowers and newspaper notices. The estimated or final prices for those items will be shown on the itemized statement describing the funeral services and merchandise you selected. We charge you for our services in buying certain items.

However, any funeral arrangements you select will include a charge for our services. Alternative Services

Direct Cremation \$3,010.00

Which includes the local transfer of remains to the funeral home, services of Funeral Director and Staff, necessary authorizations, filing death certificates, basic local transportation of remains by livery to the crematorium, an alternative container for cremation and the return of the remains to the funeral home for presentation to the family.

Which included the services as described above but where the purchaser provides the container.....\$2,660.00

- *If you choose to arrange a direct cremation, you may use an unfinished wooden box or an alternative container. Alternative containers can be made of heavy cardboard, pressed wood or composition materials (with or without an outside covering) or may be pouches of canvas or other materials. (FTC) "If you want to arrange a direct cremation, you use an unfinished wooden box or an alternative container. Alternative containers can be made of materials like heavy cardboard or composition materials (with or without outside covering), or pouches of canvas."*
- *The direct cremation prices do not include the crematory charge.*

Direct Burial \$3,655.00

Which includes the local transfer of remains to the funeral home, services of Funeral Director and Staff, necessary authorizations, filing death certificates, basic local transportation of remains by livery to cemetery and an alternative container or cloth covered wood casket.

Which includes the services as described above but where the purchaser provides the casket.....\$2,660.00

- *The direct burial prices do not include cemetery charges or outer interment receptacle (which may be required by cemetery).*

Transfer of Remains

Transfer of remains to the funeral establishment including personnel, equipment and vehicle

Local: within 30 miles.....\$500.00

Preparation of Remains

Embalming (including use of preparation room)\$975.00

Embalming of autopsied remains\$1,075.00

*in New York State, embalming is not required by law. If you do not want embalming, you have a right to choose an arrangement which does not require you to pay for embalming such as direct cremation or direct burial. If you select certain funeral arrangements, such as viewing or an open casket funeral, embalming may be required by the funeral firm. (FTC) "Except in certain cases, embalming is not required by law. Embalming may be necessary, however if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement which does not require you to pay for it, such as direct cremation or direct burial. *Firm policy is embalming is required for viewing or an open casket funeral.*

Other Preparation (including embalming)

Preparation of the remains, unless selected, is not required for direct cremation or for direct burial.

Arrangements

(FTC) "This fee for our services will be added to the total cost of the funeral arrangements you select. This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving of remains."
