Minutes of Shabbington Parish Council meeting held on Monday 12th June 2023

Attendees

1. Apologies for absence.

None.

2. Declarations of interest in items on the agenda.

None.

3. To approve the Minutes of the Parish Council meeting held on 9th May 2023.

The minutes were approved and agreed as a true record.

4. Public participation

It was reported that the hedge along Mill Road is overgrowing the pavement. The verges are due to be cut this week by RTM which may make the pavement more accessible. This will need to be reviewed once the verge has been cut.

5. Matters arising from previous Minutes

- Wooden kissing gate to Millennium Field. Action: Chairman to organise repair.
- Painting of container on Millennium Field. A competition for the design needs to be organised, this will be advertised in the newsletter.
- Bin at the Millennium Field. Due to be installed at the end of June.
- Leaning tree by Limes Way. Action: Cllr Powell to obtain 2 more quotes for removal of the tree and to obtain estimate for road closure.
- MVAS. Councillors agreed to the purchase and installation of 3 posts on which to mount the MVAS at a cost of £2250. The agreed sites are opposite Dukes Close, opposite the Church and on Crendon Road. Some trimming of trees will be required before the installation. Speedwatch sessions will take place over the summer once the camera has been registered.
- **Encroaching trees/bushes on Marsh Road.** Some pruning has been done but further cutting back is needed. A 3rd letter may need to be sent.
- **Footpath to A418.** Cllr Powell received a letter back from Greg Smith stating this was not a priority. Cllr Powell will keep pushing this forward and develop a plan to take to Lottery funding.
- **Neighbourhood Plan.** Cllr Hardy will look at Neighbourhood Plans from nearby villages which are available on the internet. The first step is to define the village boundary.

6. Shabbington Nature Network Update.

It was reported that the monthly water testing of the River Thame was done on 3rd June. The recent Eco Café was well attended. John Coates attended the Haddenham & Waddesdon Community Board event "Building a Community Vision" which took place on 7th June. It was an opportunity to network which may lead to collaboration with a nature group in Quainton. Proposals for a willow maze on a 10-15 metre square area of the Millennium Field and ideas for two pieces of play equipment that could be

made will be presented at the next meeting. SNN would like to involve children in the village in this project.
