8. Planning

The resident of Wynwood, Limes Way has brought to the attention of the PC the issue of a tree leaning on the fence which goes from the noticeboard to the Pond Garden. There is a line of 6 lime trees, 5 outside the property boundary and one inside. The resident would like to replace the fence with a brick wall but it will probably be too near the trees. The resident would like to explore the possibility of removing the leaning tree. **Action:** Chairman to advise the resident to contact planning at Bucks Council, Aylesbury Vale area. The Chairman is also concerned about the leaning pine tree on Crendon Road. Cllr Rand will come out and have a look at the trees in question.

9. Street lighting & street repairs

- The street light on Crendon Road opposite Limes Way is out again, it seems to fail in wet weather. The Clerk has reported it to Aylesbury Mains for repair on 4th October. **Action:** Clerk to get an update from Aylesbury Mains.
- A complaint has been received regarding Fieldside on Ickford Road. There are 2 concrete rounds on
 the pavement with a chain hung between them. It is thought they were placed there to prevent
 cars from parking there. A little girl tripped over the chain and concerns have been raised that
 further accidents may occur. Action: Chairman to confirm when Cllr Rand visits whether the
 concrete rounds are on the land belonging to Fieldside or on the public pavement.

10. Millennium Field & Pond Garden

- Cllr Neil is trying to get hold of the wood preserver to paint the wooden structures in the play area but it is currently out of stock.
- Pond Garden maintenance a lot of pruning is required, perhaps a working party is needed to carry out the work, to be discussed with the gardener.
