a. For Information:

i. Supervisor's Report – Rev. Melody, Pastoral Charge Supervisor

- -the Regional Council Commission met recently, but were not able to achieve quorum, unfortunately leaving the review of the disbanding date for Holy Trinity until their next meeting
- -Rev. Melody is of the opinion that the disbanding date will be December 31, 2023, so as to be in line with CRA guidelines regarding when final tax receipting will be complete.

ii. Trustees - Russ Foy, Chair of Trustees

- a) Closing Date for the Church Building
 - -the church building and property has been sold to the City of Elliot Lake for \$100,000
 - -the closing date for the sale is Friday, October 6th
 - -since Holy Trinity is considered a heritage building, it will remain as it is now
 - -an extra 60-days grace has been provided to allow for the sale of large item chattel including the organ and pews.
 - -Congregants questions:
 - 1) has there been any interest in the organ?
 - -Answer: there have been two inquiries and the distance to transport the organ became issues
 - 2) would the City be willing to keep the organ
 - -Answer: it could be up for discussion if no buyer is found

- b) Disbursements of Holy Trinity Funds
- -as a reminder regarding disbursement of funds, when a community of faith decides to disband, the assets will be directed as follows:
- 10% to Mission and Service
- 10% to Indigenous Church
- 3% to UCC Archives
- 27% can be directed by the soon-to-be disbanded community of faith (-to be approved by Regional Council)
- 50% to Regional Council for the continuation of UCC ministry in Northern Ontario
 - -Holy Trinity Trustees sent out a congregational email on Sep 29th with their proposal regarding the distribution of funds, by percentage, to a list of registered charitable organizations. The list represents the total of 100%.
- 1. St. Joseph's Hospital Foundation (including Palliative Care, Pastoral Care, Oncology, etc.) 40%
- 2. Elliot Lake Food Bank 25%
- 3. Camp McDougall 15%
- 4. St. Andrews United Church, Blind River 10%
- 5. St. Andrew's United Church, Massey 10%

<u>Motion CW-28-2023</u>: the congregation approves the Trustees' proposal for the distribution of Holy Trinity funds to the five listed registered charitable organizations. Moved by Louisa Poynter; Seconded by Ken Pierce; **Carried.**

-there are plans for a public recognition of the gifts
