• The Board reviewed the minutes of the June 18<sup>th</sup> Board meeting. Chairman, Mike Boinski made a motion to approve the minutes and Vice Chair, Carl Allison, seconded the motion.

#### **Treasurers Report**

• The Board reviewed the financial reports for the month of June 2025. Chairman, Mike Boinski made a motion to approve the Treasurers report pending audit, Director, Patty VanScoy seconded the motion.

#### All Directors in Favor. Motion carried. Treasurers Report approved.

#### **New Business:**

 Rich Birks and Matt Regan presented our final annual 2024 audit. The District had a clean audit with minimal suggestions and no financial control issues. A copy of our audit is available upon request. Director Margaret Smith made a motion to approve our annual audit. Chairman, Mike Boinski seconded the motion.

#### All Directors in Favor. Motion carried.

• There has been a lot of discussion in the senate special session. The Board discussed the need to continue our contract with the Lobbyist as of August 1<sup>st</sup>. Director Margaret Smith made a motion to continue our contract with Gamble and Schlemeier. Chairman, Mike Boinski seconded the motion.

#### All Directors in Favor. Motion carried.

• Chief Large contacted Cullen Murski, the farmer leasing the station 4 property, to let him know that we will be planning on construction of station 4 soon. He has clover planted and will continue to keep that in place until we are ready to turn dirt on the property.

#### **Unfinished Business:**

- Chief Large met with the attorney over the HVAC system at station 3. They are still having a humidity issue. The architect is meeting with Chief Large to try and get the issue solved.
- Construction has started on Wyatt Rd. and Kat Excavating has been working closely with us to ensure the roadway
  is passable at all times.

## **Chief's Report:**

- The District has placed an ad in the KC Star with the RFQ for the construction of station 4 and will be posted on our website. All bids are due September 1<sup>st</sup> by 3:00.
- The District has been approved by the DHSS for the purchase of a Safe Baby box to be installed in station 4.
- The District is still working on a list of surplus properties to be sold on purple wave.
- We are currently finishing up a true specification for the fire truck and then we will be RFP'ing the build specs to all
  interested vendors.
- Negotiations for the renewal of our MOU with local 3133 have begun and should be ready for review soon.
- **Deputy Chief Price:** Chief Price and Chief Rennolds will be attending an asset manager class help by Salamander Technologies. They are the company that handles ID cards.
- Fire Marshal Josh Sidebottom: The Construction of QT is still progressing. The Footings of the new Sonoco have been poured.
- Assistant Chief Rennolds: There were 93 alarms in the district for the month. We received mutual aid 1 time and gave aid 7 times. Average turnout time was 1.20. He is setting up the onboarding for Pulse Point, reconciling the current asset list and preparing for NERIS reporting system.
- **Battalion Chief Wheeldon:** Training for the month included CEUs for trauma and chest trauma and water rescue. There is new simulation software so the firefighters can train more realistically.
