### Alternative Services

#### **Direct Cremation \$3,500-\$3,895**

Our charges for Direct Cremation (without ceremony) include necessary services of funeral director and staff, a proportionate share of overhead costs, transfer of remains from place of death to our funeral home, transfer to/from crematory, and obtaining the necessary authorizations. The direct cremation prices do not include outside charges such as the crematory charges, cash advances such as permits and death certificates, or any ceremonies, visitation, or merchandise.

If you want to arrange a Direct Cremation you may select an alternative container. Alternative containers encase the body and can be made of materials such as fiberboard or composite materials (with or without an outside covering,) or may be pouches of canvas or other materials.

If you do not want embalming, you have the right to choose an arrangement which does not require you to pay for embalming such as direct cremation or direct burial. If you select certain funeral arrangements, such as viewing or an open casket funeral, embalming may be required by the funeral firm.

Preparation of the remains, unless selected, is not required for direct cremation or for direct burial.
