Communities in Action is a collaboration between our current New Church Development and Public Mission Committees. This collaboration aspires to facilitate Christian leaders in navigating the present post-Christian, pluralistic society where injustice and inequity continue to pervade, and to support one another in discovering ways to respond with love and courage in their communities. In addition, our collaboration seeks to inspire, empower, and support congregations and/or faith groups in their work towards justice and human rights, with the purpose of proclaiming the gospel of Jesus Christ and being peacemakers in our world.

1. How does the proposed ministry align with the overall narrative of Communities in Action? (100-200 words)
2. How does your proposal contribute to supporting, nurturing, and providing resources to multigenerational immigrant families in your community? Explain some practical ways you can implement it. (150-200 words)
3. How will you evaluate the success of your project? What will be different for you and the immigrant families you serve in the community? (150-200 words)
4. Who are the people involved in “Embracing Community showing love to immigrant families? (100-150 words) *The description must show that over 50% of the persons involved will be from outside the church (those who are not yet part of the church family).*
5. What are the primary goals and objectives for your project? (Consider SMART: Goals **should** be specific, measurable, achievable, realistic, and timely.) (200-300 words)
6. Please submit a budget for how requested funds will be used. **Please note: funds should not be used for any administrative costs or facility improvement.**

Additional Grant Requirements

- Provide a summary statement about the aims of the ministry. This description will be shared on the website and at the Annual Session should you be selected.
- *Grant recipients must submit a 6-month progress report.* You can share through pictures, videos, and/or written summaries.
- Grant recipients must participate in a one-time gathering to share their Communities in Action journey with other 2025-2026 grant recipients. Date to be determined.
