The staff at Bradley-Kosec Funeral Home & Crematory is ready and willing to serve the needs of you and your family at any time of the day or night. *Our goal is to assist you in coordinating memorable services that reflect and celebrate the unique life your special loved one lived and the impact they had on those they leave behind.* We know death is a very difficult and uninvited subject, please do not hesitate to ask *any* questions you may have. Be assured that our commitment to you does not end at the end of services; we are here to assist you in every way possible.

### Your Options for Payment

**Our payment policy requires each account be settled during the arrangement conference or before final disposition.**

#### *Insurance Assignments*

This process, if allowed by the insurance company, pays the funeral bill directly from the policy proceeds. Following our payment, any remaining balance is paid directly to the named beneficiary. To accept an insurance assignment, we require a copy of the policy, assignment form, signature of the beneficiary and confirmation from the insurance company that the policy is in-force and payable to the funeral home, and that there are sufficient funds to honor the assignment.

#### *Visa, Master Card, American Express or Discover Cards accepted*

Many families appreciate the ease and rewards (i.e. frequent flier miles, cash back) associated with credit and bank check cards. Therefore, we will process these requests electronically from our office and receive immediate validation. For your convenience, we can split the funeral cost between multiple credit cards (or methods of payment) if desired. In cases where credit card limits are already reached, financial institutions will often extend the limits for payment of death-related expenses. **Please be aware that there is a 3% processing fee for ALL debit or credit card or ACH transactions.**

#### *Cash or Personal Check*

We are, of course, prepared to provide a receipt for all cash payments. Personal checks are acceptable when drawn on local banks. When out-of-area checks are offered we may require more detailed identification. **There will be a \$25.00 returned check fee for all declined or insufficient checks.**

#### *Estate Billing /Non-Payment of Account Charge*

Probate and estates may take anywhere from several months to years to settle. In consideration of this, Bradley-Kosec Funeral Home & Crematory will add \$2,500.00 to any contract amount in which we will have to bill an estate and/or wait for payment. This includes funeral bills left unpaid greater than 30 days in which we have to file any type of claim for payment as well as families who initially agree to pay the contract amount up front, then request that the funeral bill be paid from an estate.

## ITEMIZED SELECTIONS

The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any item you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

### PROFESSIONAL SERVICES:

**Basic Administrative and Professional Services of Funeral Director and Staff..... \$2,095.00**

➔ *This is a non-declinable charge*

Our basic service charge includes, but is not limited to, the following:

Licensed personnel available 24 hours a day, 365 days a year, to respond to calls and/or requests for service. Arrangement conference with family or other responsible parties, telephone calls, emailed arrangements, or fax services. Coordination of service arrangements with clergy, musicians, cemetery, crematory, vault companies, individuals and/or organizations involved with the final disposition of deceased. Clerical assistance in completion of various forms associated with the funeral (Veteran, insurance & Social Security notification, composition and submission of obituary, etc...) Preparation of death certificate for certification by the attending physician or coroner; Securing, completion and filing of the death certificate and disposition permit with the State Health Department

**This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in all of our Funeral Service Packages, immediate burials, and forwarding or receiving remains.)**

### PREPARATION OF THE BODY:

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with a viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

Refrigeration per day (For public health & safety, RCW 18.39.215 of Washington state law mandates refrigeration of an unembalmed body after 24 hours. Charges apply after 3 days of refrigeration) ..... \$45.00

Use of Facilities and Staff for Bathing and Dressing by family/church ..... \$150.00

(Our services include set-up of visitation area with casket placement, receipt and arrangement of flowers, supervision of music as well as attendance throughout the visitation.)

**Use of Facilities and Staff Services for Funeral Service in our Chapel** ..... \$395.00  
(Our services include the coordination and direction of the funeral service, arrangement with clergy, lodge, military or other organizations, vocalist and/or other musicians, pallbearers, florists, receipt and arrangement of flowers, ushering of service attendees as well as supervision of cemetery/crematory services. Handing out memorial folders or assisting with register book- folders/book sold separately.)

Handing out memorial folders or assisting with register book – folders/book sold separately.)

**Staff Services for Memorial Service (w/o remains present) at Other Facility** ..... \$395.00  
(Our services include the coordination and direction of the memorial service, arrangement with clergy, lodge, military or other organizations, vocalist and/or other musicians, florists, receipt and arrangement of flowers and ushering of service attendees. Handing out memorial folders or assisting with register book – folders/book sold separately.)

**Use of Equipment and Staff Services for Graveside Service** ..... \$350.00  
(Our services include coordination and direction of the graveside service, arrangement with clergy, lodge, military or other organizations, vocalist and/or other musicians, florists, receipt and arrangement of flowers as well as accompaniment of casket to the cemetery.)

## SERVICE PACKAGES

**FORWARDING OF REMAINS TO ANOTHER FUNERAL HOME: ..... \$2,650.00**

This charge includes a proportionate share of the basic administrative and professional service of the funeral director and staff, local transfer of decedent from place of death to funeral home, embalming, dressing & casketing and transportation to SeaTac Airport. This charge does not include visitation, rites or ceremonies prior to forwarding of body, combination shipping unit or air tray, nor does it include actual airline transportation costs.

**RECEIVING REMAINS FROM ANOTHER FUNERAL HOME: ..... \$1,850.00**

This charge includes a proportionate share of the basic administrative and professional service of funeral director and staff, transportation from Seattle International Airport and attended delivery to a local cemetery. This charge does not include funeral home merchandise, visitation, rites or ceremonies, nor does it include cemetery charges.

**INTERNATIONAL SHIPPING DOCUMENT PROCESSING..... from \$450.00**

\* (Fee added when dealing with American & Foreign Consulates, Embassies, Customs to include Embalming Statements, Notarized Statements of Non-contagious diseases, Authentications, Apostilles, etc. Cash Advance fees may also apply and vary.)

**IMMEDIATE BURIAL: ..... \$42,895.00 to \$1,895.00**

Our charge for immediate burial includes the basic administrative and professional service of the funeral director and staff, local transfer of decedent from place of death to funeral home, service/utility vehicle and transportation to a local cemetery(within 30 mile radius). This charge does not include use of facilities and staff for any visitation or ceremony, public or private, prior to burial.

Immediate burial with container provided by the purchaser ..... \$1,895.00  
(all burial containers must comply with any applicable state or cemetery requirements)

Immediate burial with casket selected from our funeral home ..... \$1,895.00  
(in addition to the cost of the casket)

**DIRECT CREMATION: ..... \$6,350.00 to \$1,800.00**

The charge for a cremation arrangement includes a proportionate share of the basic administrative and professional service of funeral director and staff, creating and filing of WA State Death Certificate, local transfer of decedent from place of death to funeral home, service/utility vehicle, 3 days refrigeration, and the crematory fee. **This charge does not include an urn or the use of facilities and staff for any visitation or ceremony, public or private, prior to cremation.**

\*Washington State Law requires that any person cremated be cremated in a cremation container. Cremation containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The minimum cremation container we provide is a fiberboard container.

Direct Cremation with minimum cremation container provided by funeral home ..... \$1,895.00

Direct Cremation with a cremation container provided by the purchaser ..... \$1800.00  
(all containers must comply with any applicable state or crematory requirements)

Direct Cremation with casket or cremation container selected from our funeral home..... \$1800.00

**GRAVESIDE SERVICE with VIEWING ..... \$3,550.00**

Included are: basic administrative and professional services of the funeral director and staff, local transfer of decedent from place of death to the funeral home, embalming and other preparation of the body, use of facilities, staff and equipment for the visitation, use of equipment and staff at the graveside service, funeral coach, and service/utility vehicle

**GRAVESIDE SERVICE (without embalming and/or visitation) ..... \$2,850.00**

Included are: basic administrative and professional services of the funeral director and staff, local transfer of decedent from place of death to the funeral home, alternative care and preparation of the body, 3 days of refrigeration, use of equipment and staff at the graveside service, funeral coach, and service/utility vehicle

**CHURCH OR CHAPEL SERVICE FOLLOWED BY CREMATION ..... \$3,925.00**

Included are: basic administrative and professional services of the funeral director and staff, local transfer of decedent from place of death to the funeral home, embalming and other preparation of the body, use of facilities, staff and equipment for the visitation, use of facilities, staff and equipment for the church or chapel service, funeral coach, service/utility vehicle and the crematory fee

**VISITATION FOLLOWED BY CREMATION ..... \$3,420.00**

Included are: basic administrative and professional service of the funeral director and staff, local transfer of decedent from place of death to the funeral home, embalming and other preparation of the body, use of facilities, staff and equipment for the visitation, service/utility vehicle and the crematory fee

**CREMATION FOLLOWED BY A MEMORIAL SERVICE ..... \$2,865.00**

Included are: basic administrative and professional services of the funeral director and staff, local transfer of decedent from place of death to the funeral home, 3 days refrigeration, use of facilities, staff and equipment for the church or chapel memorial service, service/utility vehicle and the crematory charge

**INFANT/CHILD SERVICES (17 years and under) ..... No Charge**

Included are: basic administrative and professional services of the funeral director and staff, local transfer of decedent from place of death to the funeral home, embalming and other preparation of the body, use of facilities, staff and equipment for the visitation & funeral, funeral coach and service/utility vehicle. (For families who desire cremation, the crematory charge is also included.)

## BURIAL AT SEA OPTIONS

**IMMEDIATE BURIAL AT SEA:** ..... \$1,895.00

Our charge for immediate burial at sea includes the basic administrative and professional service of the funeral director and staff, local transfer of decedent from place of death to funeral home, service/utility vehicle, filing necessary EPA permits, and local transportation to vessel for burial at sea. This is at our convenience and family is notified once the water burial is completed. This charge does not include use of facilities and staff for any visitation or ceremony, public or private, prior to burial, or container to hold decedents body for water burial.

**OCEANSIDE BURIAL AT SEA:** ..... \$2,850.00

Included are: basic administrative and professional services of the funeral director and staff, local transfer of decedent from place of death to the funeral home, alternative care and preparation of the body, 3 days of refrigeration, funeral coach, service/utility vehicle, local transportation to vessel for burial at sea, filing necessary EPA permits, family participation for service aboard the vessel prior to burial at sea. Does not include weights or container to hold decedents body for water burial or any viewing or services prior to boarding the vessel.

## GREEN OPTIONS – coordinated with 3<sup>rd</sup> Party Facility/Business

**AQUAMATION:** (*also known as Alkaline Hydrolysis or Water Cremation*) ..... \$2,450.00

The charge for an aquamation arrangement includes a proportionate share of the basic administrative and professional service of funeral director and staff, local transfer of decedent from place of death to the funeral home and/or aquamation facility, service/utility vehicle and the aquamation facility fee, mailing of Remains to Bradley-Kosec Funeral Home for release to family. This charge does not include an urn or the use of facilities and staff for any visitation or ceremony, public or private, prior to aquamation.

**TERRAMATION:** (*also known as Natural Organic Reduction or Composting*) ..... \$6,250.00

The charge for a terramation arrangement includes a proportionate share of the basic administrative and professional service of funeral director and staff, local transfer of decedent from place of death to the funeral home and/or terramation facility, service/utility vehicle and the terramation facility fee. This charge does not include the use of facilities and staff for any visitation or ceremony, public or private, prior to terramation.

- Laying in Ceremony (additional) ..... \$1,000.00

**GREEN BURIAL:** ..... \$2,850.00

Included are: basic administrative and professional services of the funeral director and staff, local transfer of decedent from place of death to the funeral home (30-mile service area), alternative care and preparation of the body, use of equipment and staff at the graveside service, funeral coach, and service/utility vehicle. This charge does not include the cost of a shroud, carrier, ferry charges, or cemetery charges, discussed below.

**Willow Carrier** ..... 5'9" \$840.00 / 6'5" \$875.00

Green burials are often restricted by cemetery regulations. Two nearby cemeteries that allow green burial are Hillcrest Cemetery on Bainbridge Island and Sunnyside Cemetery in Coupeville, Whidbey Island. Green burial is also allowed at Quilcene Cemetery, restricted to Quilcene residents only. Embalming of the body is not allowed with green burial. \*\*Greenwood Cemetery in Chimacum is in progress for developing a Green Section.
