Charged by the Bereavement Authority of Ontario when any funeral home or cemetery services are contracted.	
Clergy/Celebrant Honorarium	\$350.00
Clergy or celebrant to conduct prayers or a service.

Staff Fee for Urn Committal Services	\$550.00
Staff to attend a graveside committal service before interring the cremated remains.	
Document or Clothing Pick Up	\$150.00
Staff will visit your home to pick up completed documents, clothing, or other items. This does not include staff for the full arrangement process.	
In-Home Arrangement	\$250.00

PAYMENT, FINANCING AND FUNDING

- **Payment**

Unless otherwise specified, payment is due upon signing of contract. Payment may be made by cash, debit, cheque, email money transfer, and most major credit cards. Beyond the allotted time, interest will be charged at 1.25% per month (15% per annum).

Cash and debit payments must be made in person at our office. We do not accept American Express.

- **At Need Funding**

Interest fees waived if we receive confirmation that payment will come from life insurance or an account in the beneficiary's name. If finances are an issue, contact us about funding through social services, OPGT, or city programs that assist with funeral expenses.

- **Pre-payment Funding**

Two funding options available when prepaying services or supplies:

- **Trust:** Money placed in trust where it accrues interest until contract is fulfilled (services and supplies delivered) or contract is cancelled. Interest helps offset inflation. You will not pay additional for equivalent services at time of need.
- **Insurance:** Purchase of insurance or annuity contract facilitated where policy proceeds pay for services or supplies at time of delivery. You will not pay additional for equivalent services at time of need.
