### INTENT CONTRACT 2025-2026

To provide for a good Catholic Education, the student and parent(s) agree to the following principles and procedures:

**HANDBOOK** – All students are required to comply with the directives in the Parent/Student Handbook. Parents and/or legal guardians agree to the directives in the school handbook as well as those found in letters, flyers, or other school communications. St. John's conducts business with the parents and legal guardians of the students. Although grandparents, baby sitters, and others who take care of children may do the work of parents, they are not necessarily legal guardians. It is up to parents to inform them about school procedures when necessary. Full cooperation of legal parents and/or guardians with school and parish administration is a must for continued enrollment and student success. Non-compliance may result in loss of enrollment.

**LITURGY** – Liturgy and prayer are a regular part of the school program for the spiritual formation of a student. Students are to be on time for the All School week day Liturgies. Students agree to cooperate with active participation at Liturgies and to conduct themselves in a devout manner during all religious functions. Catholic parents are expected to model and encourage full participation in parish activity including regular attendance at the Saturday or Sunday Liturgy at St. John the Evangelist Church and financial support of the parish.

**MORAL CONDUCT** – All students are expected to show charity to others. Courteous behavior and respect for the rights and property of others are expected of all students at all times, e.g., in the classroom, the vicinity of the school, traveling to and from school as well as at school related functions off the premises.

- Serious violations of good conduct will not be tolerated, e.g., vandalism, vulgarity, obscenity, fighting, "play-fighting".
- Courtesy and cooperation with teachers and other students is expected of all students and all parents.
- Respect for authority is expected of all.
