Successful Spring Meeting Brings Healthcare Leaders Together in Casper

Over 40 healthcare leaders from across the state gathered in Casper during the last week of May for the Wyoming Hospital Association Spring Meeting. The event proved to be an energizing and collaborative forum for discussion, insight, and statewide networking.

A highlight of the meeting was the powerful presentation on "Governance: A Call to Action" and "Building a Better Board", offering board members and administrators actionable tools to strengthen governance and improve leadership practices within their organizations. This session was provided by Stacy Cantu.

Wyoming State Senator Eric Barlow delivered a timely legislative update, covering key healthcare policy developments, funding initiatives, and what Wyoming providers can expect in the months ahead. His remarks sparked engaged dialogue and a sense of unity in moving forward.

The agenda also featured peer-led roundtable discussions, allowing participants to share successes and challenges from their communities, brainstorm solutions, and strengthen professional networks. Attendees expressed appreciation for the opportunity to connect, learn, and collaborate in person.

If congressional proposals go into effect, hospitals — especially in rural and underserved areas — will be forced to make difficult decisions about whether they will have to reduce services, staff and potentially consider closing their doors. In this video, Ruby Kirby, R.N., CEO of Bolivar General Hospital and Camden General Hospital in Tennessee, explains why rural Americans need Medicaid and why Congress must protect it.

AHA Report Finds Workplace and Community Violence Costs Hospitals More Than \$18 billion Annually

The American Hospital Association released a new, comprehensive **report** that measures the substantial financial resources hospitals and health systems spend on preventing and responding to violence in their facilities and communities. Prepared by Harborview Injury and Prevention Research Center, part of the University of Washington School of Medicine, the report analyzes the financial costs and broader impacts of violence and threatening behavior and found that the total financial cost of violence to hospitals in 2023 was estimated at \$18.27 billion. These costs include health care treatment for victims, security staffing for health care facilities, and violence prevention programs and training, among other costs.

"It is an unacceptable reality that those who dedicate their lives to healing should face the threat of violence," **said** AHA President and CEO Rick Pollack. "We know the enormous human and

emotional toll violence takes on our communities and caregivers. This report goes beyond that to break down the significant related financial costs incurred upon hospitals and health systems. With the increase in violent events within clinical settings across the country, the resources needed to protect hospital workers and care for victims has grown exponentially. Every member of the health care team bears an enormous risk and burden of this violence. This report is yet another reminder we must do more to protect them."

Cancer Center Receives ACS

Transportation Grant



Sweetwater Regional Cancer Center recently received a \$6,000 grant from the American Cancer Society to provide transportation assistance to people with cancer during treatment from April 1, 2025, through March 31, 2026.

"We are deeply grateful to the American Cancer Society for their generous grant, which allows us to provide gas cards to our cancer patients," said Tasha Harris, dosimetrist and Memorial Hospital of Sweetwater County Radiation Oncology Director. "We have many patients who travel long distances to come to treatment every day. This becomes a financial burden. Transportation should never be a barrier to receiving life-saving care, and thanks to ACS, every gas card brings hope, healing, and the support our patients need."

The grant is part of the ACS nationwide investment of \$9 million that is expected to provide nearly 63,000 eligible patients with nearly 800,000 transportation and lodging services.

Access to high-quality cancer treatment impacts cancer outcomes. A lack of the transportation and lodging needed to receive quality care can lead to missed appointments, treatment interruptions, and delays in follow up care. In a 2023 Journal of the National Cancer Institute **study**, American Cancer Society researchers found that delayed care due to lack of transportation is associated with increased emergency room use and mortality risk among adults with and without cancer history. "Transportation obstacles or the cost of a hotel room should not be barriers that determine the survival of those needing cancer treatment," said Dr. Arif Kamal, chief patient officer for the American Cancer Society. "Partnering with health systems and organizations across the country to provide funding to deliver the direct assistance needed helps to fill these equity gaps and improves cancer outcomes.

The American Cancer Society believes all people should have a fair and just opportunity to live a longer, healthier life free from cancer regardless of how much money they make, skin color, sexual orientation, gender identity, disability status or where they live. In addition to providing transportation and lodging funding to health systems and organizations, the American Cancer Society runs a **Road To Recovery** program that provides free rides to and from treatment and over 30 **Hope Lodge** communities that provide a free place to stay during treatment.
