# Wyoming Governor's Challenge Suicide Prevention Among SMVF

#### **Background**

Wyoming joined the VA's Governor's and Mayor's Challenges to Prevent Suicide Among Service Members, Veterans, and their Families (SMVF) in 2021. Since then, the Wyoming Governor's Challenge team has been developing and implementing state-wide suicide prevention best practices for SMVF, using a public health approach. Wyoming's team is focused on three priority efforts: 1)Identifying SMVF and screening for suicide risk. 2)Promoting connectedness and improving care transitions. 3)Increasing lethal means safety and safety planning.

#### **Call to Action**

Healthcare professionals often encounter veterans, service members, and military families without always knowing it. Veterans do not always identify themselves. Asking, "have you or a family member ever served in the military?" can insure proper identification of SMVF which in-turn can facilitate appropriate diagnosis, treatment planning and referrals. We invite you to join in our effort to prevent veteran suicide by implementing the "Ask The Question" campaign in your intake process and sharing that data in the steps below.

#### **Caring Contacts**

Caring Contacts is an evidence based intervention model recommended by multiple clinical practice guidelines. Caring Contacts are brief, periodic messages sent over 1-2 years that express unconditional care and concern. This intervention has been shown to reduce suicide, suicide attempts, and suicide ideation.

#### Wyoming211 CommuniCare

CommuniCare, the Wyoming Community Information Exchange powered by Wyoming 211, was created in response to the need to better connect providers of all types through one electronic platform. With client consent, CommuniCare partners are able to create care coordination teams to streamline communication and access real-time updates. Access to the entire Wyoming 211 database makes CommuniCare a one-stop location for referrals. This program is staffed by CommuniCare navigators who can work with patients opted-in to Caring Contacts as a way to extend the support provided to a patient after discharge.

## A Look at the Usage Data

### Between January of 2024 and August of 2025

The Park, Natrona, and Goshen County Library Booths hosted a cumulative:

- 192 total users
- 19,033 minutes of use

#### Park County


- · 10,030 minutes total, 528 minutes/month
- 103 total users, 5.7 users/month


#### Natrona County

- 5,640 minutes total, 267 minutes/month
- · 45 total users, 2.3 users/month

#### Goshen County

- 3,843 minutes total, 202 minutes/month
- · 44 total users, 2.4 users/month





#### In addition to 1:1 Telehealth Appointments

- Library staff reported patrons regularly coming into the booth to use the accessory health equipment, like blood pressure cuffs and scales, located in the booths.
- The space is frequently used for a quiet private space to access healthcare information.
- In Goshen County, a HeartCorps member promoted the booth within the community and utilized the booth to conduct educational webinars.

### These data are exciting!

They demonstrate there is need and excitement surrounding the booths, and now we need to focus on getting the word out!

Currently, were working to connect with providers licenses in WY, to make sure they know this community resource exists!


