Evanston Regional Hospital Opens Permanent Wyoming Life Flight 3 Air Base

AirMethods has opened Wyoming Life Flight 3 air ambulance base at Evanston Regional Hospital (ERH).

AirMethods is a private company that has contracted with the hospital to provide 24/7 access to emergency air services. Wyoming Life Flight 3, based at ERH, provides service to a large area of southwest Wyoming, including Evanston, Kemmerer, Bridger Valley, Pinedale and more. They provide transfer service from hospital to hospital, to industry and the mines, and for accidents on Interstate-80. Stokes said they have been contacting other agencies in the area to make them aware of the services Wyoming Life Flight 3 provides.

Two clinicians (a flight nurse and a flight medic) and a pilot will be on staff at the hospital 24/7. The clinical team rotates after a 48-hour shift with another clinical team; the pilots work 12-hour shifts with seven days on and seven days off. The crew has secured shared housing near the hospital.

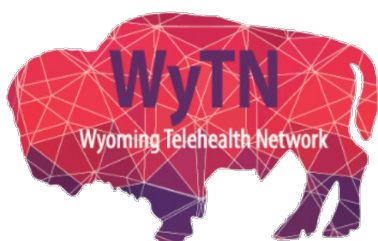
WyTN - Current Telehealth Landscape in Wyoming

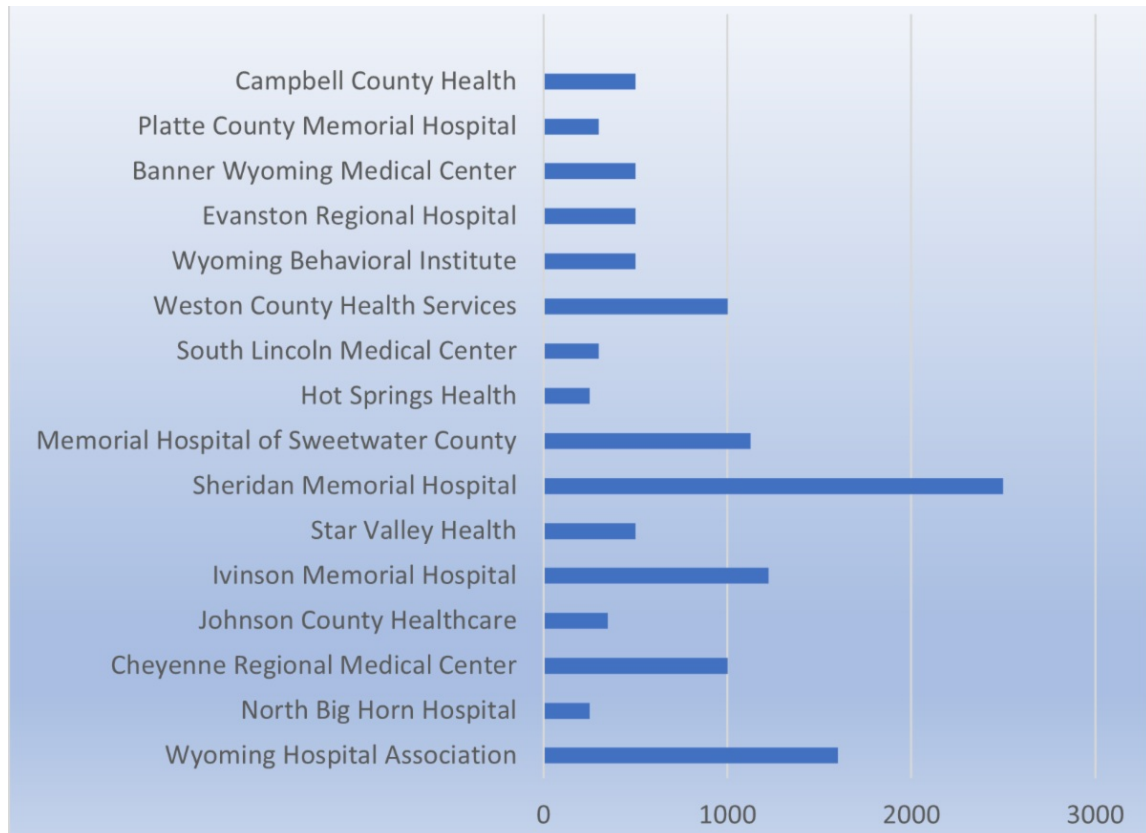

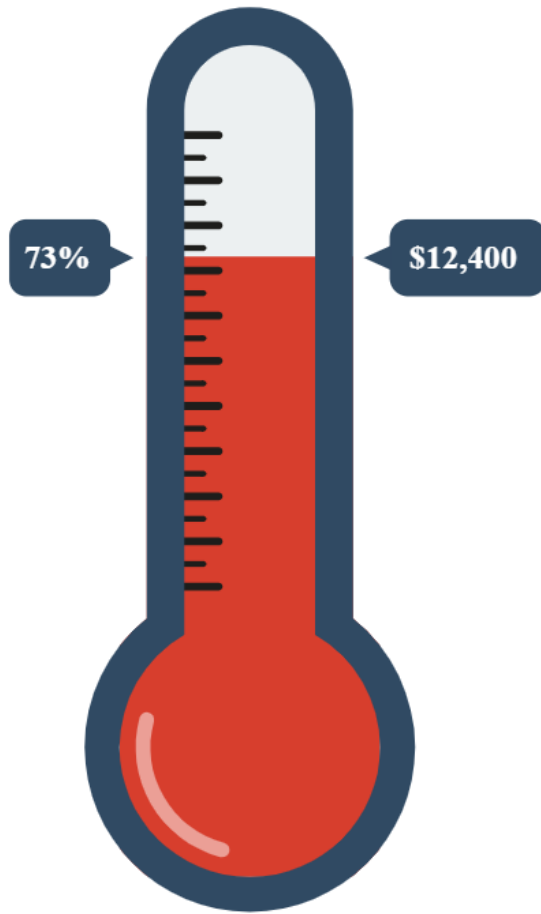
