Critical Medicare Support for Rural Hospitals at Risk: Congressional Action Needed

Rural hospitals across the United States are facing an urgent financial crisis as two vital Medicare payment programs are set to expire on September 30, 2025, without immediate congressional intervention. The enhanced Low-Volume Adjustment (LVA) and Medicare-Dependent Hospital (MDH) programs provide essential financial support that helps rural and geographically isolated hospitals maintain operations and serve their communities.

Legislative Solutions on the Table

Congress has two opportunities to address this critical need through bipartisan legislation currently under consideration:

The Rural Hospital Support Act (S. 335) in the Senate would make the LVA and MDH programs permanent, providing long-term stability for rural hospitals. Additionally, the bill would provide an additional base year for Medicare-Dependent Hospitals and Sole Community Hospitals to calculate payments, potentially increasing support for many facilities.

The Assistance for Rural Community Hospitals (ARCH) Act (H.R. 1805) in the House would extend the enhanced LVA and MDH programs for five years, providing crucial breathing room for rural hospitals while longer-term solutions are developed.

Understanding the Programs at Risk

Low-Volume Adjustment (LVA) provides additional Medicare payments to hospitals that treat fewer patients, recognizing that lower patient volumes result in higher per-patient costs due to fixed overhead expenses that must be spread across fewer cases. This program is particularly vital for small rural hospitals that serve scattered populations.

Medicare-Dependent Hospitals (MDHs) receive enhanced payments as facilities that serve

populations with high Medicare utilization rates. These hospitals, often located in rural areas with aging populations, depend heavily on Medicare reimbursement to maintain financial viability. Sole Community Hospitals (SCHs), while not facing immediate expiration, also benefit from the broader rural hospital support framework and would gain additional support under the proposed Senate legislation.

Take Action Now

Time is running out for congressional action before the September 30 deadline. Healthcare advocates, hospital administrators, and community members must contact their representatives immediately to ensure these vital programs continue.

Contact your senators and ask them to cosponsor the Rural Hospital Support Act (S. 335). Contact your House representatives and ask them to cosponsor the Assistance for Rural Community Hospitals Act (H.R. 1805). Most importantly, request that lawmakers include these rural hospital extenders in any "must-pass" legislation moving through Congress before the end of the month.

The Stakes Are Clear

Without immediate action, rural communities across America will face the loss of essential healthcare services. Hospital closures would force residents to travel significant distances for emergency care, surgical procedures, and other critical medical services. The ripple effects would extend beyond healthcare, impacting local economies and quality of life in rural areas. The data is clear, the need is urgent, and the solutions are ready for congressional approval. What's needed now is the political will to act before it's too late for America's rural hospitals and the communities they serve.




