The citizens of Holmes County and visitors have seen a significant improvement in the condition of our County roads over the past seven years with the 0.25% sales tax. Although the prices of asphalt paving are up, we continue to remain on schedule to complete our goal of paving the rest of the roads in this 5 year renewal cycle. Since the 0.25% sales tax was passed we have improved close to 210 miles of our 250 miles of roads.

This year we are planning to bid out approximately 19 miles of paving: CR 27–0.5 Miles, CR 59 – 4.3 Miles, CR 114 – 5.6 Miles, CR 270 – 0.08 Miles, CR 280 – 3.0 Miles, CR 349 – 4.2 Miles, CR 391 – 0.2 Miles, CR 392 – 0.2 Miles, CR 393—0.4 Miles, and CR 625—0.5 Miles.

We are planning to replace/rehab 5 bridges this year with our own crews, which include CR 58-0551, CR 58-0557, TR 28-0136, TR 362-0064 and TR 470-0079.

I respectfully submit this annual report required by Ohio Revised Code Ch. 5543.

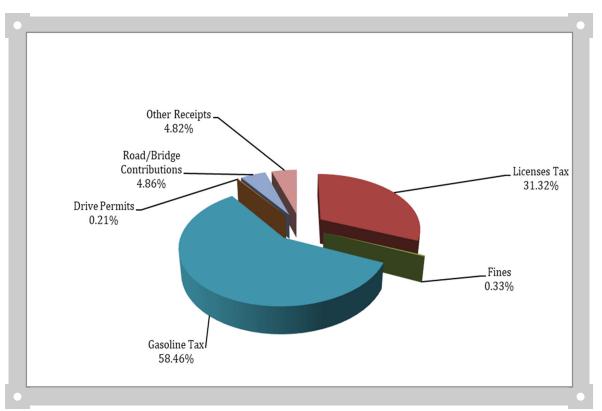

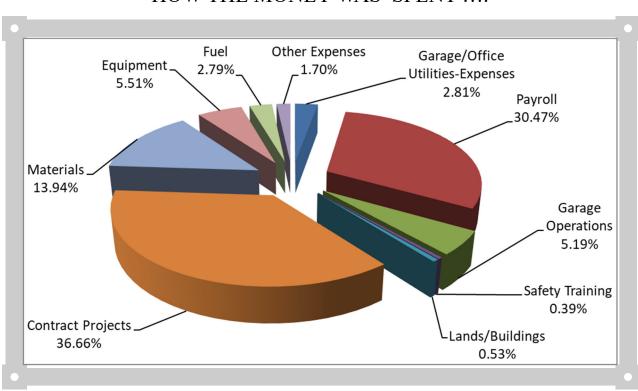
