

# Lincoln Police Department Monthly Report

September 2021

**Report Summary** 

Beginning on Monday, August 30, 2021, all individuals in Illinois who are age two or over and able to medically tolerate a face covering (a mask or cloth face covering) shall be required to cover their nose and mouth with a face covering when in an indoor public place.

Lincoln Police responded to 959 incidents for the month and 99 case reports were written for the month. Officers responded to 38 vehicle crashes. Patrol officers wrote 49 traffic citations and 51 warnings for the month along with 6 City Ordinance Citation and 1 City Ordinance Cannabis Citation.

Of the 51 arrests for the month, officers arrested several for, warrants, domestic battery and resisting a peace officer. Of the 51 arrest, there were 5 incidents were the officers had to use force to gain control of the offender. Detectives continued investigations on 24 cases including participating in CIEG task force operations.

The K9 unit was only dispatched one in the month of September.

DARE was able to sponsor some youth activates this month and personally help some students with necessities.

The goals of well-founded SRO programs include providing safe learning environments in our community's schools, providing valuable resources to school staff members, fostering positive relationships with youth, developing strategies to resolve problems affecting youth and protecting all students, so that they can reach their fullest potentials.

There were 38 crashes the Lincoln Police Department responded to for the month of September.




# **MONTHLY STATISTICS**


## **Uniform Crime Reporting (UCR)**





# **Criminal Investigations**

The detectives of the Criminal Investigation Division of the Lincoln Police Department conducted further investigation on  $\underline{24}$  active criminal investigations in the month of September. The types of investigations are listed but due to the sensitivity of those investigations, specific information is not available for release.

- (8) Investigations involved sexual offenses.
- (5) Investigations involved crimes against persons.
- (4) Investigations were property related.
- (7) Investigations were narcotics related.
- (4) Search Warrants were obtained to further these investigations.
- Two officers of the Criminal Investigations Division continued to participate in a multijurisdictional drug task force, conducting joint investigations with other local, state, and federal agencies.

#### **DARE/Community Policing**

DARE was able to be a sponsor for the Deputy Scott Brown Scholarship Fund Golf Outing in September. The Scholarship Fund is a memorial fund that will offer scholarships to four students annually, one from each high school. The student has to be a Logan County resident who is a graduating senior from Lincoln Community High School, Hartsburg/Emden High School, Mt. Pulaski High School and Olympia High School.

Dare was able to contribute to the Logan County Quail and Upland Game Alliance annual Youth Dove Hunt. DARE was also able to help a couple of LJHS with furnishing them with clothes and shoes that were very necessary for them.

#### Lincoln K9

Officer Sullivan and K9 Ace were dispatched only once the month of September. It was a vehicle search were there was a positive indication.

#### School Resource for LCHS and District #27

The goals of well-founded SRO programs include providing safe learning environments in our community's schools, providing valuable resources to school staff members, fostering positive relationships with youth, developing strategies to resolve problems affecting youth and protecting all students, so that they can reach their fullest potentials. The three main roles of school resource officers are: educator (i.e. guest lecturer), informal counselor/mentor, and law enforcement officer.

Officer Butterfield has been helping with Standard Response Protocol training and Stop the Bleed Training for the Lincoln Public Library, Open Arms Church and teacher aids. He also conducted safety inspections at the Library. 233 people, in total, have been trained in Stop the Bleed in the months of August and September. In addition to the training he has been holding, he has responded to incidents at LCHS about class misconduct and incidents that required parental contact, parking issues, E-Cig/Vape violations and thefts.

Officer Fruge has responded to incidents at LJHS about harassment/bully, fighting, social/emotional issues and general counseling issues that required parental contact.
