Report Summary

Lincoln Police responded to 1125 incidents, which resulted in 119 case reports written for the month of September. Officers responded to 20 vehicle crashes. Patrol officers wrote 45 traffic citations, 41 written warnings and 4 city ordinance citations.

Of the 51 arrests for the month, the top arrests were for warrants, driving under the influence and domestic battery. Detectives continued investigations on many cases including participating in CIEG task force operations.

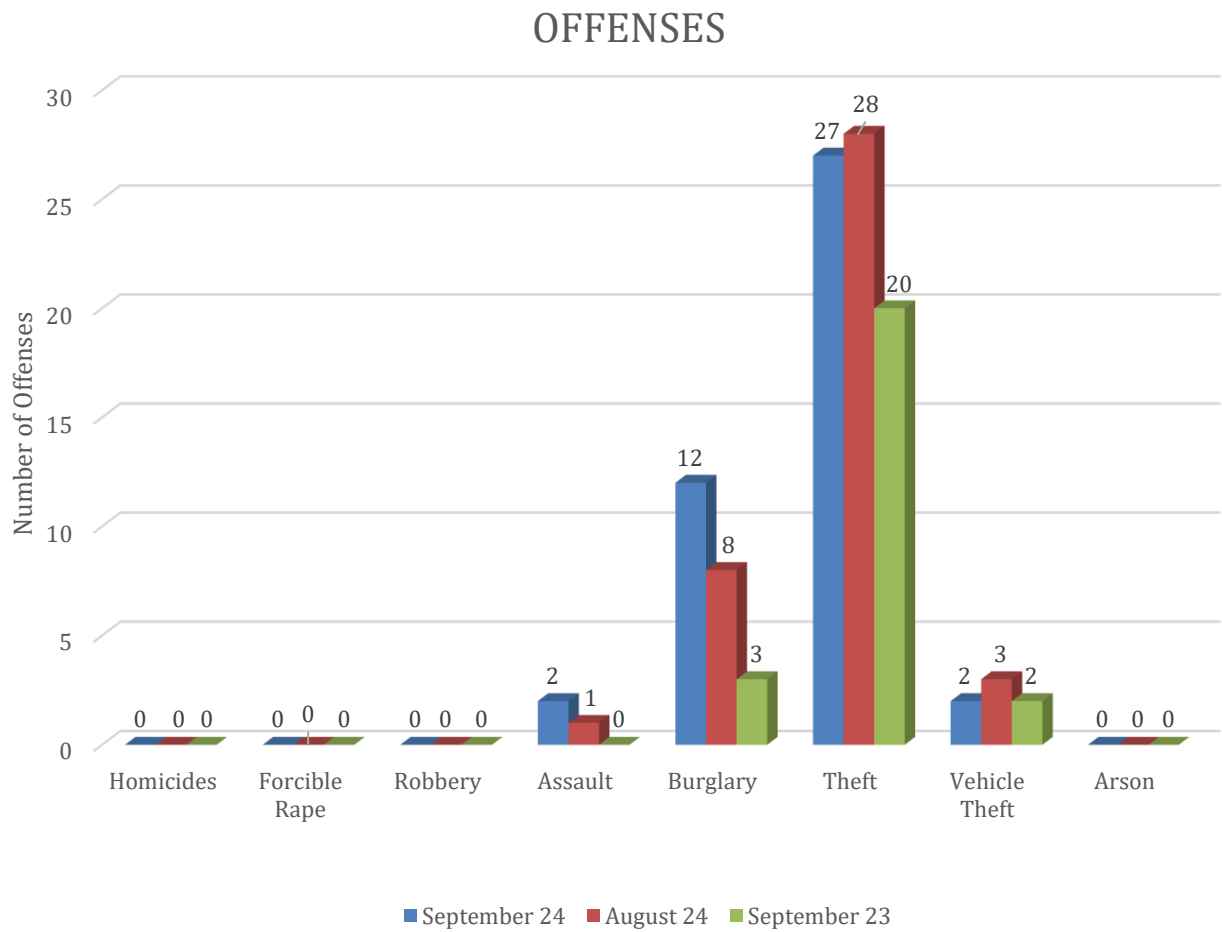

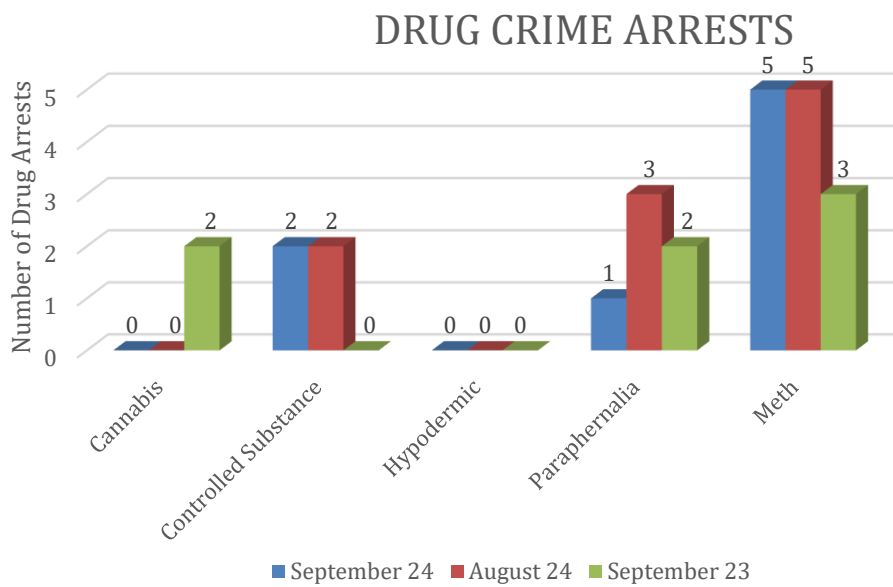
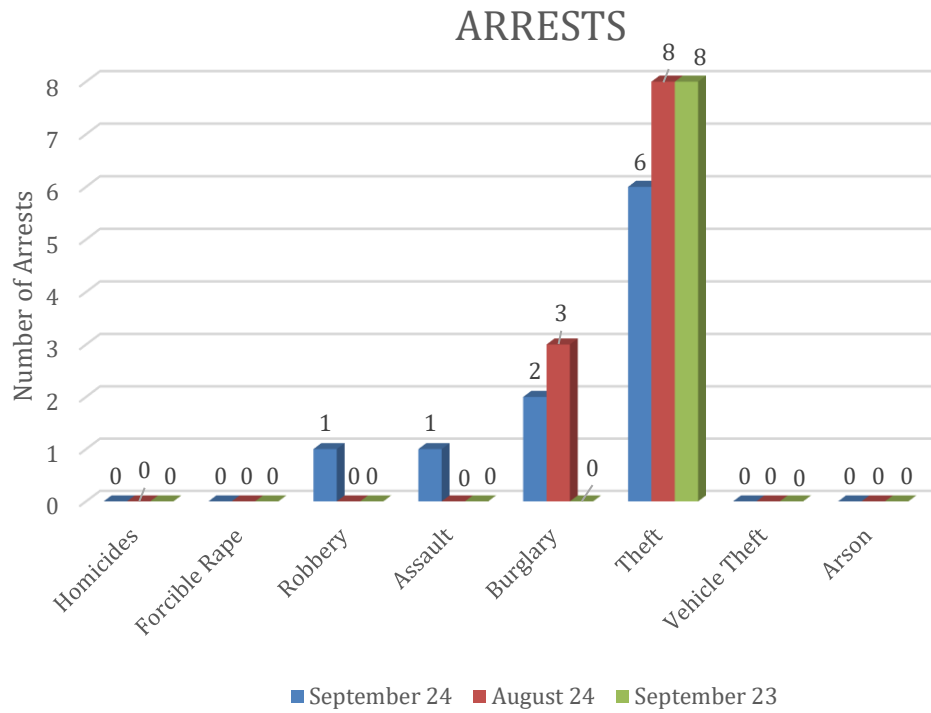
MONTHLY STATISTICS

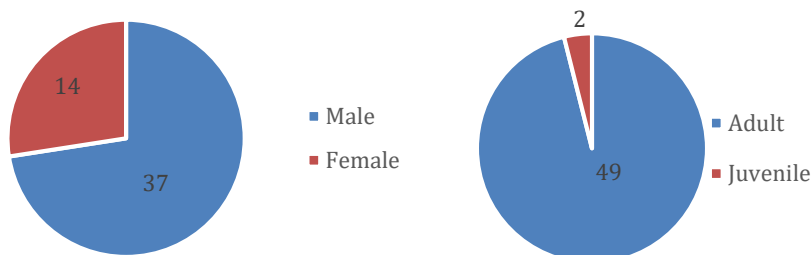

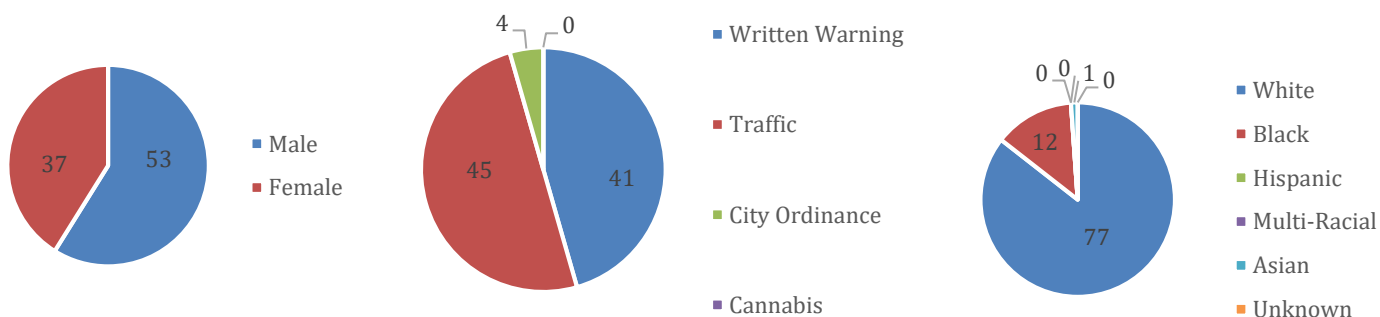

DIVISION REPORTS

Criminal Investigations

The detectives of the Criminal Investigation Division of the Lincoln Police Department conducted further investigation on 13 active criminal investigations in the month of September. The types of investigations are listed but due to the sensitivity of those investigations, specific information is not available for release.

- (2) Investigations involving sexual offenses.
- (5) Investigation involving burglary.
- (4) Investigations were narcotics related.
- (1) Investigation involving domestic battery.
- (1) Investigation involving a drug induced homicide.
- One officer of the Criminal Investigations Division continued to participate in a multi-jurisdictional drug task force, conducting joint investigations with other local, state, and federal agencies.

Officer Phillips and K9 Diesel had 6 deployments during the month of September. On those deployments, there were 6 search areas all being vehicles. There were 9 indications out of the deployments with 9 items being seized including drugs (methamphetamines and marijuana) and drug paraphernalia. These indications resulted in 3 arrests, two females and one male.

Officer Phillips and K9 Diesel spent 17.5 hours training during the month of September.

DARE/Community Policing

The Department supports the DARE program and its efforts to assist youths with sound judgement and decision making, including but not limited to resisting drug/alcohol abuse and prevention of bullying at home, at school and in their community.

DARE was able to donate to the LCHS Move Club, LJHS 8th grade nights for Baseball and Softball, the Wells Hunter Safety Course, the City of Lincoln Movie Night and wacky Olympics at Adams School and LCHS. DARE was also able to help multiple students with school supplies and clothing. DARE was also able to help the family from the Sangamon Street Fire.

School Resource

The goals of well-founded SRO programs include providing safe learning environments in our community's schools, providing valuable resources to school staff members, fostering positive relationships with youth, developing strategies to resolve problems affecting youth and protecting all students, so that they can reach their fullest potentials. The three main roles of school resource officers are: educator (i.e. guest lecturer), informal counselor/mentor, and law enforcement officer.

SRO Rohrer responded to incidents of alcohol/tobacco/vape issues, social/emotional mental health issues, and other general counseling issues. SRO Rohrer spoke to the Criminal Justice Class.

SRO Christy Fruge responded to incidents of social/emotional/mental health which involved counseling issues, battery/assault/threat issues and alcohol/tobacco/vape issues.
