Item 6: Chairman's Report

"Good afternoon, ladies and gentlemen

It is with a great honour that I am here as Chairman once again, second time around. Last year unfortunately Mrs Sue Williams felt her personal circumstances meant she could no longer continue in the role of Chairman and therefore she resigned with only a small window before the AGM. As time was short a new chairman was required. Tom Dale became acting chairman for those few weeks to ensure the club continued to run smoothly however he felt he wasn't in a position to take the chairmanship for the coming year. As this was very close to the AGM, and after speaking to a number of past chairmen and committee members I stepped back in so this club could still continue to move forward.

With plenty to look forward to in the coming year with the 7000th celebration rally, the new committee set about confirming roles and responsibilities. Dates were set for meetings throughout the year, with us reducing the number of meetings and not all being face to face with the use of MS teams, therefore reducing travel and cost to committee members and the centre. Over the last 12months the centre has added new equipment including event shelters, heaters and lights for use on rallies.

We also agreed to continue to utilise the assistance of Andy Gibbs as our centre webmaster and I thank him for his continued support to the centre during this last year. Andy does a great job, and the website is always kept up to date with the latest centre news.

The programme for 2025 was ratified and plans to publish the rally book was underway. It seemed online bookings were deemed a success, and we opted to keep this in place alongside postal bookings giving rally officers the choice of how to take their bookings.

It was great to see a strong junior committee this year lead by Alex Cook. With full numbers and a great mix of young and older juniors, they all have worked extremely hard helping out on rallies, providing the much loved tuck shop and running their own rally. Thank you to all parents and grandparents for their continued support.

2025 was a huge milestone in the centres history and the committee were meeting on a regular basis led by sub committee chairman Tom Dale to deliver a fantastic 7000th rally for all the centre to celebrate and enjoy. With over 220 outfits attending and many more members coming as day visitors this was a huge success and something we should all be proud of. I would like to personally thank our main sponsor Glossop Caravans for their continuous support towards our centre and golf society.

The Centre's golf society are due to celebrate 50 years in 2026. Can I thank the outgoing captain Martin Kay and wish the society and the new captain success in its celebratory year. They are always looking for new members if anybody would like to join.

I would also like to thank all the rally officers who take time out to organise and run rallies for the centres benefit. This is very much appreciated and without you we wouldn't have such a wonderful choice of rallies each weekend. For those thinking about running a rally please get in touch and we will always help, the more the merrier, it's not as hard as you might think it is.



As the new 2025/2026 committee is formed, we welcome 3 new members. I would like to thank the past years committee members for all their hard work, commitment and dedication over this past year. Item 7: Treasurers Report

"Good afternoon, Ladies & Gentlemen.

In my report, I will present the Centres accounts for the year ending 31st December 2024. Copies of the accounts were made available as you entered the hall, I hope you have all have a copy.

The Accounts have been drawn up in the same format as previous years which are those laid down by the Caravan & Motorhome Club.

Just the accounts pages are numbered. Pages 1 and 2 show the balance sheet and pages 3 and 4 show the income and expenditure account of the Senior section for the year. Page 5 shows the Junior's accounts.

Please turn to page 3 of those accounts.

You can see that the Net Surplus of £103 in 2023 is down to a loss of £79 in 2024. This is mainly due to a reduced grant from the Caravan & Motorhome Club, and a small number of last minute rally cancellations where rally plaques have already been purchased, or deposits lost.

Please turn to page 4 of the accounts.

Overall, our total expenditure was £5,220, up by £2,253, due in the main to increased depreciation of assets, more face to face committee meetings and reduced advertising income. This gave us a nett loss of £1,720, which compares to a surplus of £1,092 last year.

We should bear in mind that these accounts are lower than the true cost of running the centre, because your committee have not claimed back any of the expenses that they personally incur.



Page 5 shows the Juniors results for 2024. The Junior Treasurer gave an account of their finances at the Junior AGM meeting earlier today. Please turn to page 2.

This section of the balance sheet shows purchases of £736. This covers various rally equipment purchases. In 2023 this was higher as we needed to replace laptop computers for the Treasurer, Secretary and Rally Secretary.

The results of the senior and junior sections are added to the net assets of the centre and this is reflected in our balance sheet, which is shown page 2, the total assets are £34,268. £3,263 of this belongs to our Junior section.

This now concludes my report on the Centre accounts for 2024.

Going forward, it is essential that we as a Centre keep a close eye on three important factors, to ensure that we continue to flourish in the coming years:

- 1. Equipment purchases
- 2. Advertising income, which have fallen in recent years
- 3. Contribution from rallies I know that this has been suspended for 2026, but we may not be able to afford to maintain this forever.

I have every confidence that the new committee will be diligent in this area.

Finally, my thanks go to my wife Jane. She has been my right-hand woman throughout the last three years, without whom I would not have been able to complete the role of Treasurer. "
