# CONGRESS VS. IOWA LEGISLATURE


### CONGRESS AND THE IOWA LEGISLATURE BOTH MAKE LAWS AND PASS BUDGETS.

**Congress** is the lawmaking (legislative) branch of the United States. It passes laws that apply to all states and develops budgets that fund our **federal government**. The laws passed by Congress apply to everyone, in all states.

The **Iowa Legislature** is the lawmaking (legislative) branch of the State of Iowa. It passes laws that apply to people in Iowa and sets a budget that funds our **state government**. Laws in Iowa may be different than the laws of other states. For example, some states have no sales tax and others have no income tax. Iowa has both.

It can sometimes be hard to figure out which lawmaking body has jurisdiction over an issue. For example, Congress requires states to pay for certain Medicaid services but gives states the right to decide on other services. Medicaid is also paid in part by the federal government and in part by state government.

## NAVIGATING CONGRESS

### ABOUT THE US CONGRESS

#### **THERE ARE 535 PEOPLE ELECTED TO THE US CONGRESS.**

The US Senate and the US House of Representatives make up the two chambers of the US Congress.

**There are 100 US Senators.** Each state elects two US Senators and those Senators represent everyone in that state. Republicans control the US Senate with 53 Republicans. There are currently 37 Democrats in the US Senate.

**The US House has 435 members that represent a part of their state (called a district).** The number of districts each state has is based on its population. California has the most (52) and six states have only one US Representative each. Iowa has four districts - and four US Representatives. Republicans also have control of the US House of Representatives with 220 members. There are 215 Democratic members.

Congress meets year-round, but takes frequent breaks to give members time to go back to their states and meet with the people they represent. They typically meet four days a week, with a weeklong break each month. They also break for an entire month in August. **DID YOU KNOW?** If the US Senate vote is tied (50-50), the Vice President breaks the tie with their vote!

# THE LEGISLATIVE PROCESS IN THE US CONGRESS

### LAWS START OFF AS AN IDEA BUT THEY NEED A MEMBER OF CONGRESS TO SPONSOR.

Ideas for laws come from many places - organizations, elected officials, or constituents. To start the process, a member of Congress must turn that idea into a bill by sponsoring it. The member of Congress who asks for a bill becomes the lead sponsor. Other members of Congress can sign on as sponsors to that bill at any time in the legislative process. This is often a big advocacy push for many organizations.

**Asking your members of Congress to sign onto a bill is an example of federal advocacy.** An important way to improve the bill's chance for success is to get a long list of Republican and Democratic sponsors. This shows broad support for an idea, which makes it more likely to move through the process. Once a bill is introduced, it is assigned to a committee for study. If a committee decides the bill should move forward (called "releasing" the bill), it will be placed on the calendar to be debated. At this time the bill may be amended before a vote is called.

**Bills must pass by a simple majority** in the House (218 out of the 435 members) and Senate (51 of the 100 members). If the bill passes both chambers in different forms, a conference committee is assigned to work out differences. Once those differences are worked out, the House and Senate will vote on the compromise before it moves to the President of the United States. The President then has 10 days to sign or veto the bill.

# WHAT CAN MY MEMBER OF CONGRESS DO FOR ME?

### A MEMBER OF CONGRESS' JOB IS TO REPRESENT THE PEOPLE OF THEIR STATE.


US Senators represent every person in their State. US Representatives represent the people of their district. Members of Congress have large staffs, including some based in Washington DC, some assigned to specific committees, and others who are located in their state.

Iowa's congressional delegation all have district offices where staff can help you with any concerns you have with the federal government. Some things they may assist:

- \* Help you get tickets for visits when you are in Washington DC (gallery passes, tours).

- \* Troubleshoot problems you are having with a federal agency (like problems with Social Security or passports).
- \* Listen to your ideas for laws or request a hearing on a topic
- \* Help students with US Service Academy nominations, Page applications, and internships.
- \* Help recognize people from the district for their accomplishments.
- \* Request to receive a flag that was flown over the US Capitol.



## NAVIGATING THE LEGISLATIVE PROCESS ABOUT THE IOWA LEGISLATURE


### **THERE ARE 150 LEGISLATORS IN IOWA'S LEGISLATURE.**

Some states have more, some less. Iowa's Legislature has two parts: the Iowa House of Representatives and the Iowa Senate.

**There are 100 Representatives serving in the Iowa House of Representatives**, or the "Iowa House" for short. Representatives serve two-year terms so they will be up for election again in November 2026.

**There are 50 Senators in the Iowa Senate**. They are elected to four-year terms. Half of the Senators will be up for election in November 2026 (the 25 with odd-numbered districts), and the other half will face re-election in November 2028 (the 25 that are in even-numbered districts).

Legislative districts are drawn so that every Iowa Senate district includes two Iowa House districts. Every Senator represents about 63,800 people and every Representative represents about 31,900 people.



One Representative and one Senator represent you at the Iowa Capitol.

In 2025, one in six legislators is new.

# WHAT CAN MY LEGISLATOR DO FOR ME?

### A LEGISLATOR'S JOB IS TO REPRESENT THEIR DISTRICT

Legislators are elected to represent the people who live in their districts (called "constituents"). They have many roles, but they are mainly problem solvers. They pass laws, decide how to spend taxpayer dollars, and help solve problems their constituents have with laws or government.

The job of a legislator is part-time in Iowa. The Legislature meets for 110 days in the first year of a two-year term (2025), and for 100 days in the second year (2026).

Your legislators work at the State Capitol from January to April, but the rest of the time they have other jobs. They are teachers, farmers, insurance agents, and small business owners. Some are retired and some are students. They are Iowans just like the rest of us.

Your legislators work for the people living in their district. That means they work for you. They are *public servants*; their job is to serve the public.

# HOW CAN MY LEGISLATORS HELP ME?

**Most legislators use social media.**

**Consider following them on Facebook, X, Instagram, and YouTube.**



If you have concerns about issues that are affecting you, your family, your community, or the state, contact your legislators. They represent you. You do not need to know how to fix the problem (although it helps if you do). Some problems are tough, and your legislator can pull in experts to help find a solution. They are problem solvers.

Iowa legislators don't have big offices and a large staff. They have a desk and filing cabinet on the floor of the House/Senate and a session-only clerk who helps them file papers. That means legislators are easy to find and respond personally to calls, emails, and letters.

# NAVIGATING THE IOWA LEGISLATURE

## THE LEGISLATIVE PROCESS IN IOWA

### INTRODUCTION

Ideas for bills can come from anyone and anyone can write a bill. However, only legislators, the Governor, or a state agency can introduce it. If you have an idea for a bill, you need to get one of these people to sponsor (introduce) it.

### THE LEGISLATIVE PROCESS

#### STEP 1. REFERRAL TO COMMITTEE

Once a bill is introduced, it is referred to a standing committee in the House or Senate. The House Majority Leader makes these assignments in the House; the President of the Senate does it in the Senate.

#### STEP 2. SUBCOMMITTEE REVIEW

The committee chair assigns the bill to a subcommittee (usually three legislators). The subcommittee holds an open meeting in which the public, lobbyists, and others can express their views about the bill and ask for changes. These meetings are often informal, but on bigger issues, the subcommittee may do formal hearings that require the public to sign up to speak. Subcommittee schedules are posted daily on the website [legis.iowa.gov](http://legis.iowa.gov). A bill's chance for survival is often determined at this early level.

#### STEP 3. COMMITTEE ACTION

If the majority of the subcommittee members approve the bill, it can move on to the full committee for action. The committee can amend the bill or pass it with no changes. If the committee does not act on a bill, it will not move on to the next level (the bill "dies" in committee).

### THERE ARE 3 BASIC TYPES OF BILLS

#### INDIVIDUALLY SPONSORED BILLS

A legislator or group of legislators requests these bills and their names are listed as sponsors. They are House File (HF) or Senate File (SF).

#### STUDY BILLS

Only committee chairs can request these bills. They do not have a legislative sponsor (the committee is the sponsor if action is taken). Bills requested by the Governor's Office and state agencies also come out in the form of a study bill. They are either Senate Study Bill (SSB) or House Study Bill (HSB).

#### RESOLUTIONS

Resolutions do not change law; they express the thoughts of the Legislature on a topic. Sometimes they urge Congress to take action or recognize a group or person.

Sometimes legislators have fun with resolutions. In 2017, three legislators sponsored a resolution about the importance of the pork industry – their names were Fry, Moore, Bacon.

## THE LEGISLATIVE PROCESS IN IOWA

### THE LEGISLATIVE PROCESS (continued)

#### STEP 4. DEBATE

Once a bill passes out of committee, it is placed on the Calendar. The House Majority Leader and President of the Senate decide which bills will be debated each day and place them on a smaller calendar, called the Daily Debate Calendar. Bill sponsors may have to lobby their leaders to get a bill brought up for debate. Bills can be amended at this point in time.

#### STEP 5. REFERRAL TO OTHER CHAMBER

After the House or Senate passes a bill, it is referred to the other chamber where it usually follows the same route to committee and floor action (Steps 1-4). The chamber may approve the bill as is, reject it, ignore it, or change it.

#### STEP 6. FINAL ACTIONS

There are several paths a bill may follow after it makes its way through both chambers. If the second chamber makes no changes to the bill, it goes to the Governor.

If changes are made, the bill goes back to the original chamber for approval. Lawmakers can approve the bill as changed (sending it to the Governor), reject the changes (starting the process to send it to conference committee where a group of legislators work out the differences), or make additional changes (which sends the bill back to the second chamber). This last action is often called a “bouncing bill” because it bounces between chambers until it is acceptable to both. If both chambers cannot agree with each other, the bill can either be tabled (dies) or sent to a *conference committee*. Conference committee members work out differences and then draft a report that becomes the new bill. Legislators can only vote for or against it – they cannot amend it.

#### STEP 7. GOVERNOR'S ACTION

After both the House and Senate have approved a bill in identical form, it is sent to the Governor. If the Governor approves of the legislation, she will sign it and it becomes law. If the Governor opposes the bill, she can veto it (it does not become law). In addition, if the bill is a budget bill (spends money), the Governor is allowed to veto parts of a bill, while signing other parts into law. This is called a *line-item veto* and it is only allowed for budget bills.

#### STEP 8. OVERRIDING A VETO

If the Governor vetoes a bill, the Legislature may *override the veto*. This requires a 2/3 vote and is something almost never done in Iowa.

#### A WORD ABOUT RENUMBERING

In Iowa, bills often get renumbered. Study bills get a new House File or Senate File number once they are voted out of committee. The committees are then listed as the sponsor of those bills. Bills that are amended in committee usually get a new number. Legislators do this so people will know which version of a bill they are talking about.

For example, a legislator could sponsor a bill to make dragons the state's reptile. The committee could decide that is silly since dragons are not real and amend the bill to make timber rattlesnakes the state reptile. If the bill was not renumbered, the first legislator who wanted the state reptile to be the dragon would still have their name on the bill, even if they opposed it. Also, people supporting dragons might advocate for the bill after it's amended, not knowing the bill had been changed to something they don't support.

# LEGISLATIVE SESSION TIMETABLE

## 2025 • 2026

### JANUARY 13, 2025 | JANUARY 12, 2026 . . . . .

First day of the legislative session.

### JANUARY 14, 2025 | JANUARY 13, 2026 . . . . .

Governor gives her annual *Condition of the State Address* to the Legislature and releases her budget requests.

### JANUARY 15, 2025 | JANUARY 14, 2026 . . . . .

Chief Justice of the Supreme Court gives her *Condition of the Judiciary Address* to the Legislature and releases her budget requests.

### FEBRUARY 14, 2025 | JANUARY 23, 2026 . . . . .

Last day for legislators to ask for (sponsor) bills; committee chairs and legislative leaders can continue to make requests after this date.

### MARCH 7, 2025 | FEBRUARY 20, 2026 . . . . .

First deadline, called a *funnel*. Bills have to be voted out of a House or Senate Committee by this date in order to stay alive and remain eligible for debate (that is – past Step 3). This deadline does not apply to bills that spend money (Appropriations bills), deal with taxes (Ways and Means bills), come out of the Government Oversight Committee, or are sponsored by legislative leaders.


### APRIL 4, 2025 | MARCH 20, 2026 . . . . .

Second *funnel* deadline. Bills have to be voted out of one chamber and out of committee in the opposite chamber (or they are no longer eligible for debate). This deadline doesn't apply to tax, spending, Government Oversight, or leadership bills.

### MAY 2, 2025 | APRIL 21, 2026 . . . . .

The "Last" day of session. Legislators are paid a set salary for their work but receive daily expense payments for every day they are at the Capitol and away from home (these *per diem* expense checks help offset the cost of living away from home and traveling weekly to the Capitol). These expenses are capped at 110 days in 2025 and 100 days in 2026. After this date, legislators no longer receive these *per diem* expenses. If session lasts longer, they travel and stay at their own expense and work without staff support.

*These dates can be changed by legislative leaders (but unlikely).*







You may find that you have things in common with your legislators. You may go to the same church or graduated from the same college. You may both be farmers or have served in the US military.

When you have something in common with your legislators, it helps build a connection with them. It makes it easier to talk to them and it makes your contact with them more memorable.



# LEGISLATIVE COMMITTEES

When a bill is introduced in the House or Senate, it is sent to a legislative committee for review and public comment. The committee decides if the proposal will move on.

## THERE ARE TWO TYPES OF COMMITTEES IN IOWA

• • •

**STANDING COMMITTEES** work on policy issues in a specific area, such as transportation or taxes. The House and Senate each have their own Standing Committees and they meet separately. The exceptions are the Government Oversight Committee and the Administrative Rules Review Committee, which each meet jointly.

**BUDGET SUBCOMMITTEES** work on state budgets in a specific issue area and report their work back to the Appropriations Committee. Unlike Standing Committees, Budget Subcommittees meet jointly (House and Senate members meet together). Their job is to review requests for money, hear from the groups asking for that money, and recommend a budget to the House and Senate Appropriations Committees. Once that is done, they no longer meet.




