1. Introduction

Forensic Academy Africa is a South African Skills Development Provider focused on forensic capacity development, occupational learning and fraud management capability. The Academy supports individuals, employers and institutions through accredited skills development, assessment services and structured pipelines that build internal forensic capacity across compliance, anti-money laundering and countering the financing of terrorism (AML/CFT) capacity, investigation, administration, project control and fraud examination.

Forensic Academy Africa positions its available offerings within the programme family, Skills Development: Forensic Capacity Building, and the classification Fraud Management: A Holistic Approach. This structure helps learners, employers, and institutions identify practical progression pipelines that develop compliance, anti-money laundering and countering the financing of terrorism and forensic capacity toward holistic fraud management.

2. Vision Statement

To be recognised as a leading Southern African authority in forensic capacity development, supporting individuals, employers and institutions to prevent, detect, investigate and respond to fraud, financial crime, misconduct and compliance weaknesses.

3. Mission Statement

Forensic Academy Africa delivers accredited skills development and professional learning that grow individual capability and build institutional forensic capacity across Southern Africa. Through occupationally aligned qualifications, digital learning, and structured pipelines, the Academy supports learners, employers, and institutions in developing practical capacity for compliance, AML/CFT, investigation, analysis, fraud examination, and holistic fraud management.

4. Ownership Structure

Forensic Academy Africa forms part of a South African-owned group of companies under COFTA (Pty) Ltd. The ownership structure provides the Academy with a stable governance foundation from which to pursue its role as a specialist skills development provider focused on forensic capacity development, occupational learning and professional capability building.



Within this structure, the Academy operates as the education and skills development entity, supporting individuals, employers and institutions through accredited learning, assessment services and structured skills development pipelines. The company's ownership and governance context supports its long-term focus on sustainable education delivery, institutional credibility and capacity development across Southern Africa.

5. Company History and Strategic Evolution

Forensic Academy Africa has evolved through several strategic phases in response to South Africa's changing education, skills development and forensic practice environment. The company initially operated under the name Outsourced Learner Management and was registered as a Closed Corporation in February 1999. It was later converted to a Proprietary Limited company in February 2012, strengthening its formal corporate structure and long-term operating base.

On 17 January 2024, the company changed its name to Forensic Academy Africa, reflecting a sharper identity as a specialist provider in forensic education, occupational learning and skills development. This repositioning supported the Academy's growing role in online delivery, learner support, industry alignment and accredited forensic-related qualifications. As the South African qualification landscape continues to transition from legacy qualifications toward occupational learning, the Academy is now entering its next strategic phase: **forensic capacity development**.

This phase positions Forensic Academy Africa's available offerings within the programme family, Skills Development: Forensic Capacity Building, and the classification Fraud Management: A Holistic Approach. Through an expanded pipeline architecture, FAA supports individuals, employers and institutions in developing practical capacity for compliance, AML/CFT, investigation, analysis, fraud examination and holistic fraud management.

6. Accreditation and Quality Assurance Profile

6.1. Accreditation Overview

Forensic Academy Africa's accreditation profile supports its role as a specialist Skills Development Provider and Assessment Centre in forensic capacity development. The Academy's accredited scope includes legacy forensic qualifications, QCTO occupational qualifications and assessment centre approvals that support structured progression into compliance, AML/CFT, fraud examination and holistic fraud management capacity.



6.2. Skills Development Provider Accreditation

6.2.1. Legacy Qualifications: SASSETA - Teach-Out Period

Forensic Academy Africa is registered and accredited as a Skills Development Provider with the Safety and Security Sector Education and Training Authority (SASSETA), under accreditation ID 081985269877, for legacy forensic qualifications that have passed their registration end dates. Learner enrolment for these legacy qualifications **closed on 15 June 2026**.

Enrolled learners remain supported during the applicable teach-out period, with learning, assessment, and completion processes continuing in accordance with the applicable accreditation, quality assurance, and programme requirements. For enrolled learners, the **teach-out period runs through 31 May 2027**. No new learner uptake applies to these legacy qualifications after 15 June 2026.

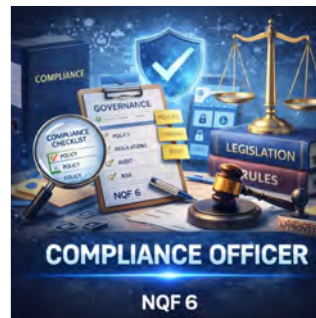

6.2.4. Accreditation Transition and Future Scope

Forensic Academy Africa continues to pursue accreditation opportunities aligned with its forensic capacity development strategy and the expansion of its skills development pipelines. This includes strengthening pipeline architecture in compliance, AML/CFT, fraud examination and related forensic capacity fields, subject to applicable accreditation, quality assurance and programme requirements.

7. Skills Development Architecture

7.1. Skills Development: Forensic Capacity Building

Forensic Academy Africa organises its current accredited and transitional offerings under the programme family, Skills Development: Forensic Capacity Building, and the classification, Fraud Management: A Holistic Approach. This structure presents the Academy's offerings as practical progression pipelines that support individuals, employers, and institutions in developing compliance, AML/CFT, and forensic capacity for holistic fraud management.

7.1.1. Fraud Management: A Holistic Approach

This classification assists learners, employers and institutions in understanding how different occupational, administrative, compliance, AML/CFT and legacy forensic foundations can advance holistic fraud management capacity.

7.1.1.1. Occupational Identities

The architecture of this classification speaks to five occupational identities: Project Manager, Office Administrator, Compliance Officer, Anti Money Laundering Analyst and Fraud Examiner. 8. Target Markets

Forensic Academy Africa serves individuals, employers, institutions, and professional communities that require practical forensic capacity to prevent, detect, investigate, and respond to fraud, financial crime, misconduct, and compliance weaknesses. FAA's target markets align with its Skills Development: Forensic Capacity Building architecture and classification, Fraud Management: A Holistic Approach. These markets include learners seeking occupational progression, organisations developing internal forensic capacity, and professional communities requiring credible skills development pathways in compliance, AML/CFT, investigation and fraud management.

8.1. Individual Learners

Individual learners include post-school learners, legacy forensic learners, early-career entrants and mid-career professionals seeking applied progression into forensic capacity-building fields. Forensic Academy Africa supports learners whose current or intended occupational identity aligns with project management, office administration, compliance, AML/CFT, investigation, fraud examination or related forensic practice.

This market includes individuals seeking entry into occupational learning, learners transitioning from legacy forensic qualifications, and working professionals who wish to grow their capability in compliance, AML/CFT, investigation, analysis, fraud examination and holistic fraud management.



Through its structured pipelines, the Academy helps learners identify practical progression routes that align with their qualifications, experience and career direction.

8.2. Employers and Institutions

Employers and institutions include public-sector bodies, municipalities, SETA-linked employers, accountable institutions, financial services organisations, insurers, banks, forensic service providers, compliance functions, AML/CFT environments, internal audit units, risk management teams and investigation units that need to strengthen internal forensic capacity.

Forensic Academy Africa supports organisations that require staff development across project control, administration, compliance, AML/CFT, investigation and fraud examination functions. Its skills development pipelines provide structured options for employers that want to develop staff from operational, administrative, compliance, AML/CFT or legacy forensic foundations toward holistic fraud management capacity.

This market is especially relevant to institutions seeking to improve governance, compliance response, financial crime risk awareness, fraud risk management, investigation readiness, case-file discipline, reporting discipline and organisational accountability.

8.3. Professional Communities

Professional communities include compliance officers, anti money laundering analysts, AML/CFT practitioners, fraud investigators, financial crime compliance professionals, forensic practitioners, internal auditors, risk professionals, law enforcement officials, prosecutors, regulators, governance practitioners, forensic science and forensic biology legacy learners, and professionals who operate in environments where fraud, financial crime, misconduct and compliance weaknesses must be identified and addressed.

Forensic Academy Africa engages these communities by providing accredited skills development, professional learning and capacity-building pathways that support continuing professional growth and practical workplace application. These communities also serve as important bridges between individual learner demand, institutional capability needs and the broader development of forensic, compliance and AML/CFT capacity across Southern Africa.

9. Institutional Value Proposition

Forensic Academy Africa supports institutions, employers and professional environments that need to strengthen internal forensic capacity, compliance capability, AML/CFT capability, fraud management and workforce development. Forensic Academy Africa's value lies in helping organisations develop practical occupational capability that can be applied in real workplace contexts.



9.1. Internal Forensic Capacity

Forensic Academy Africa helps institutions develop internal forensic capacity by strengthening the occupational capabilities needed to recognise, organise, document, investigate and respond to fraud, financial crime, misconduct, compliance weaknesses and evidentiary risk. This includes capacity in structured assignments, case-file discipline, compliance oversight, AML/CFT support and fraud examination.

9.2. Compliance Capability

Forensic Academy Africa supports compliance capability by positioning the Compliance Officer occupation as a central occupational identity within its Compliance-Centred Forensic Capacity category. This enables institutions to develop staff who can contribute to compliance monitoring, governance awareness, support for internal controls, and organisational accountability.

9.3. AML/CFT Capability

Forensic Academy Africa supports AML/CFT capability by positioning the Anti Money Laundering Analyst occupation as the central occupational identity within its AML/CFT-Centred Forensic Capacity category. This enables institutions to develop staff who can contribute to anti-money laundering and countering-the-financing-of-terrorism awareness, monitoring, detection support, reporting discipline and financial crime risk response.

9.4. Fraud Management

The Fraud Management: A Holistic Approach classification supports capacity across prevention, detection, compliance, AML/CFT, investigation, response and accountability. By developing learners' fraud examination capabilities, institutions can strengthen their ability to manage fraud-related and financial-crime-related risks and respond more effectively to misconduct and compliance failures.

9.5. Workforce Development

Forensic Academy Africa supports workforce development by providing structured skills development pipelines that help employers align staff development with occupational progression and institutional capacity needs. These pipelines support development across project control, administration, compliance, AML/CFT, investigation and fraud examination functions.



10. Leadership and Operational Capacity

Forensic Academy Africa's leadership and operational capacity support its role as a specialist Skills Development Provider focused on forensic capacity development. The Academy operates through a lean but focused structure that combines strategic leadership, learner administration, academic coordination, assessment centre capability and subject-matter expertise. This structure enables the Academy to support individual learners, employers and institutions through accredited learning, pipeline guidance, learner support and assessment-related services.

10.1. Strategic Leadership

Strategic leadership is responsible for Forensic Academy Africa's positioning, accreditation strategy, qualification architecture, institutional relationships and long-term development as a forensic capacity-building provider. 


