- 2. Minutes from November 9, 2023, Regular Meeting were moved by Commissioner Oliver with a second from Commissioner Wolf. Motion carried. Minutes from the November 9, 2023, Special Meeting were moved by Commissioner Hayden with a second from Commissioner Oliver. Motion carried.
- 3. Treasurer's Report for November 2023 was moved by Commissioner Oliver with a second from Commissioner Hayden. Motion carried.
- 4. Middletown Cemetery Association, Inc., Board of Trustees Financial Report was moved by Commissioner Stigers with a second from Commissioner Hayden. Motion carried.
- 5. The Mayor announced that City Hall will be closed on December 25 and 26 in observance of Christmas and again on December 29 and January 1 in observance of the New Year. Commissioner Hayden announced that the new play equipment is in place at Cross Creek Park and the new equipment for Wetherby Park was delivered to the contractor with anticipation of installation occurring in January 2024.
- 6. Museum Report was given by Commissioner Stigers.
- 7. Middletown Chamber of Commerce Update by Chamber director Laura Wright. The Chamber will collaborate with the Museum to help drive awareness and visitors.
- 8. Middletown Police Department Update by Chief Rob Herman the chief announced that since his report, Off. Hundley has been promoted to Sgt. For late watch.
- 9. Middletown Public Works Department Update by Director Marty Stansbury
- 10. Update on Middletown Business License and OCC Registration nearly half of the businesses have a business license.
- 11. There were no comments to the City Commission.
- 12. KIPDA Report of ARPA

- 13. MO 12-14-2023-E Approving FY23 Audit was discussed with Paul Maddox, CPA who performed the Audit and the Single Audit required by the federal government because Middletown received ARPA funding. - 16. Ord 11-09-2023-B Short Term Rentals had a first reading on November 9, 2023, and the second reading on December 14, 2023. Ord 11-09-2023-B was moved by Commissioner Wolf with a second from Commissioner Stigers. A roll call voice vote was taken since this is an ordinance with all members voting yes. The ordinance passed.
- 17. MO 12-14-2023-A Approving Certified City of Ethics Proposal was moved by Commissioner Wolf with a second from Commissioner Oliver. Motion carried.
- 18. MO 12-14-2023-B Adopting Goals and Objectives of a Certified City of Ethics was moved by Commissioner Hayden with a second from Commissioner Stigers. Motion carried.
- 19. Discussion of the new ethics ordinance for Middletown ensued with the recommendation that there be a first reading in January with the second meeting in January used as a session to go through the proposed changes. All members agreed to this action and will read through the proposal beforehand.
