- 2. Municipal Order 02-23-2023-A Purchase of Police Equipment was amended by Commissioner Oliver for the dollar amount not to exceed \$20,000 which should cover eight shields, five tools kits and freight. The amendment was seconded by Commissioner Hayden. Motion carried. The amended Municipal Order was moved by Commissioner Oliver and seconded by Commissioner Wolf. The motion carried.
- 3. Chief Herman gave an overview of the Flock cameras that are going up in the Middletown area. Middletown currently has one and is adding three. Metro Louisville is paying for three more and the Lake Forest HOA has some along Shelbyville Road near Beckley Woods. The cost is \$3,000 per year per camera. Middletown Police (MPD) does share the data with other police jurisdiction as they also share. MPD does have a policy on the use of Flocks and the information gathered that is consistent with the policy suggested by Kentucky League of Cities.
- 4. Discussion of Wetherby Park expansion and playground was led by Kent Gootee with Mindel Scott. A consensus was reached on a draft site plan to forward to the Kentucky Department of Local Government to move the grant request forward for the play equipment. Kent had several options to include an expanded walking path with a crosswalk along Old Shelbyville Road to access the park from the south. Kent will come back to our March 23 meeting with more detailed drawings for the Commission to consider as the plans for the park evolve. The clerk will send the site plan to the Kentucky Department of Local Government to get that moving forward.
