- 2. Minutes from December 8, 2022, Regular Meeting were moved by Commissioner Wolf and seconded by Commissioner Stigers. Motion carried. The December 28, 2022, Special Meeting minutes were moved by Commissioner Hayden and seconded by Commissioner Oliver. Motion carried.
- 3. Treasurer's Report for December 2022 was moved by Commissioner Wolf and seconded by Commissioner Oliver. Motion carried.
- 4. Middletown Cemetery Association, Inc., Board of Trustees Financial Report was moved by Commissioner Stigers and seconded by Commissioner Hayden. Motion carried.
- 5. Commissioner Stigers delivered Museum Report for December 2022.
- 6. Comments to the City Commission
 - a. Cathy Tucker of St. Clair Drive asked about hiring a person to work at the Museum. It will be addressed/discussed in the next budget cycle.
 - b. Larry Speaker of St Clair Drive complimented Public Works and the others that have been working on maintaining the cemetery. It looks very nice.
- 7. Middletown Chamber of Commerce Update by Executive Director Laura Wright and she announced that they have 504 paid members now. - 11. Municipal Order 1-12-2023-C 22-DDP-0096 for 114 Urton Lane was moved by Commissioner Stigers and seconded by Commissioner Hayden.  - a. Prior to moving to hire a social media consultant, Commissioner Oliver would like to see the city finish up the social media policy and have a presentation from Kentucky League of Cities on social media for municipalities.
 - b. Attorney Singler will send out the latest draft of the social media policy. It will be on the February meeting for discussion and possible action.
