FEES

- Sign Fees: \$1.00 per square foot, \$50.00 minimum
- Banners: No charge

HISTORIC DISTRICT

- Historic District: Maximum sign or banner size is 12 sq. ft.
- Pole Signs: Maximum 5' in height and 6 sq. ft. in area
- Further restrictions for the Historic District may apply, see the City of Middletown sign ordinances or Tracy Dohn at City hall (502) 245-2762 or tracy@cityofmiddletownky.org

TEMPORARY BANNERS

- No charge
- New Businesses are allowed 30 days at the opening of the business
- Temporary banners are allowed 3 times per year for 10 days each
- Banners cannot exceed 32 sq. ft./12 sq. ft. for Historic District and cannot be freestanding.

*Prohibited signs and banners include: portable signs, balloons, mechanical reader boards, small freestanding signs, temporary freestanding signs, outdoor advertising signs such as yard stick up signs, and no flags except the American Flag.
