Wood County Training Initiative for 2024

Wood County Board of DD began the Training Initiative Program in 2022 and has committed to continuing this program through 2024. This program is intended to assist Direct Support Professional or their employer serving the people of Wood County with reimbursement of \$25.00 per hour for their time to attend training they are typically not reimbursed for. This

specifically includes training that is offered by the Wood County Board of DD or prior approval is received for outside training. Trainings offered by the Wood County Board of DD that are eligible for this program include New Independent Provider Orientation, Annual trainings, Positive Supports First, DSP Onboarding, Customized DSP Trainings, Medication Administration courses, and/or trainings required for the Competency Based and Longevity Add-On DSP Incentive. This program has limited funds and will be honored while sufficient funds exist. Participating providers will be notified via email upon the exhaustion of Training Incentive Program funds.

CPR/FA/AED Training

Wood County Board of DD offers Heart Saver CPR/FA/AED training 2-3 times per month at the Gypsy Lane Campus. Training costs are reduced for Agency Providers to \$23.50 which includes the cost of the book and e-card. At this time, training costs for Independent Providers are being waived. Medication Administration Certification

Wood County Board of DD offers Medication Administration Certification Courses for initial Category 1, 2, and 3 certificates along with Renewal Certification Courses for Category 1, 2, and 3 certificates at no cost for the Independent or Agency DSPs who serve people in Wood County. Stand Alone Medical Trainings such as VNS, EPI-Injector, OTC Topicals, or Individual Specific trainings are available upon request. In-Person Annual DSP Training 8-hours

Wood County Board of DD offers an in-person training option for Independent Providers and Direct Support Professionals working for agencies serving Wood County to meet the required 8-hours of annual training by the Ohio Department of Developmental Disabilities. There is no fee for this training, and it may be eligible for the Wood County Training Initiative for those DSPs serving Wood County.

Virtual Annual DSP Training 6-hours

Wood County Board of DD offers a virtual learning option for all providers in Wood County utilizing the county board's Relias Learning account. As a provider you can choose up to 6 hours of training from over 150 topics that have been approved by the National Alliance of Direct Support Professionals. You will be given one-week access to Relias Learning to complete your chosen training. These trainings may be eligible for the Wood County Training Initiative for reimbursement. ADS Side-By-Side Training Sessions

DSP Onboarding

Onboarding DSPs can be costly and time consuming for Agencies. Wood County Board of DD is offering to assist certified Agency Providers with onboarding of DSPs through providing training opportunities and funds to recoup the training time and costs of a new DSP. Training must be arranged and approved through the Provider Relations Department prior to DSPs attending courses. Reimbursement is available at \$25.00 an hour for eligible courses based on available funds. All DSPs are required to have 8 hours of initial training, Positive Supports First, CPR/FA, and possibly Medication Administration Category 1 or higher. The potential cost savings to an Agency Provider is \$725.50 per DSP.

Positive Supports First (Behavior Support Strategies)

Wood County Board of DD offers support to all providers with keeping the people served and their DSPs safe by offering regular Positive Support First courses: Initial, Renewals, Train-the-Trainer, and upon request person specific consultations. Frontline Supervisor Training

Frontline Supervisors or FLS are required to have annual training that establishes competency as a supervisor. Wood County Board of DD offers a virtual Frontline Supervisor Training option for all providers in Wood County utilizing the county board's Relias Learning account. As a provider you can choose trainings from over 80 topics that have been approved by the National Alliance of Direct Support Professionals. Director of Operations Training

Director of Operations or DOO are required to have 6 hours of annual training: 2 hours of DODD provided web-based training and 4 hours of training selected by the DOO in topics relevant to services provided and individuals served by the agency provider and/or management of the agency provider. Wood County Board of DD will continue to support the management teams of provider agencies by providing 4 – 2-hour training sessions in 2024.
