Steve Pedro: It's not the same person. They've done some different fundraisers for them. This is the project at Lawndale Park for Jake Brown. They are up to \$17,000 now. The wall is built, they are going to paint the Memorial Wall in the next couple weeks, the gaga pit will probably be here in another week or so, the court has been redone, the surfacing has been redone, and the playground. We planned on doing some of these things anyway. They went above and beyond. We'll work on the sidewalk and some enhanced parking there. Some other things in the future as well that we talked about.

Mr. Hickey: So, this money coming in, they just keep donating?

Steve Pedro: Yes. Then what I have to do is I have to make legislation for council and in two weeks I'll have to go there the next work session and let them know we accepted that donation. Any time we get a donation, this is what is done.

Mr. Rickett: Can we get a price on that?

Steve Pedro: Yes, I imagine it will be the same as what we are doing down at Lincoln -\$47,500. We can talk about that in my report when the Master Plan comes through. We can look at those things.

Mr. Rickett: I'd like to see that – when we see the snow flying, you think?

Steve Pedro: Anything is possible

Mr. Rickett: When are they starting the other one?

Steve Pedro: As soon as the contractor can. I wanted him to wait until this past weekend because we had the big tournament down there so I imagine if he don't call me in the next day or so, I'll call him and we'll get it scheduled. He said it would take him about eight days to set it up or to get it done. I'm going to get him and the concrete guy together and then go from there.
