### **OLD BUSINESS:**

**Mr. Hickey:** What is the progress on the Lawndale pavilion, any?

**Steve Pedro:** As I stated last week, we are going to do that after the first of the year for next year's budget. We talked about a pavilion but I think we would rather do a gazebo up there. If we do a pavilion, we will need to put a restroom in up there.

**Mr. Hickey:** Now when you say budget, it's already been approved, correct?

**Steve Pedro:** Yes, but we need to change it if we are going to change. We didn't discuss that and I didn't put it on the agenda this month. I thought we would do that the first of the year. The money is still there, it's not going anywhere.

**Mr. Colly:** It would be less money, though?

**Steve Pedro:** Well it doesn't have to. We talked about a pavilion first. That's what we voted on. After further discussion, after not being able to get drawings for a pavilion for months, and then we finally talked about putting it on hold and then we decided we were going to do a gazebo for a lot less. When I say a gazebo, I'm talking about 18'-20' in diameter with a fence around it. It's a small park but if we want to move ahead with the pavilion then we will have to put it out to bid. I think the smaller item would be better for that small park.

**Mr. Colly:** Is it like a concrete pad there?

**Steve Pedro:** Just put it on crushed limestone

**Mr. Rivera:** Would this be something that you think they would pre-build or would they build it on-site?

**Steve Pedro:** Probably build it on-site

**Mr. Rivera:** Like a skid build

**Steve Pedro:** Yes. It's too big to pick it up and bring it up here

**Mr. Rivera:** Okay, transport it

**Steve Pedro:** Yes sir. They will have to build it on-site unless we find someone that can transport it

**Mr. Rivera:** Yes, I'm not sure

**Steve Pedro:** To answer your question Mark if we could, after the first of the year, re-visit this and I will put it on the agenda

**Mr. Hickey:** Sure
